## RELEASE OF MORTGAGE

WHEREAS, on July 10, 1992, Transchio Savings Bank was closed by the Office of Thrift Supervision, ("OTS") pursuant to Section 5(d) (2) (A) of the Home Owners Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"), OTS pursuant to order number 92-307 appointed the Resolution Trust Corporation ("RTC") as Receiver of Transchio Savings Bank.

WHEREAS, on July 10, 1992, the OTS by order number 92-307 chartered Transchio Federal Savings Bank, as a federal mutual savings bank, and pursuant to Section 5(d) (2) (B) (1) of HOLA, appointed the RTC as Conservator for Transchio Federal Savings Bank.

WHEREAS, on July 10, 1992, the RTC as Receiver of Transchio Savings Bank and the RTC as Conservator for Transchio Federal Savings Bank entered into a Purchase and Assumption Agreement whereby the RTC as Conservator for Transchio Savings Bank purchased substantially all the assets, deposits and secured liabilities of RTC as Receiver of Transchio Savings Bank.

WHEREAS, as a result of the transfer from the RTC as Receiver of Transchio Savings Bank to the RTC as Conservator for Transchio Federal Savings Bank, RTC as Conservator for Transchio Federal Savings Bank having a mailing address of 1250 Superior Avenue, Cleveland, OH 44114 is the owner and holder of the below mentioned Note and Mortgage.
