Parcel A: That part of Lot 3 in Keeney Industrial District, being an Owner's Division in the South East quarter of Section 32, Township 40 North, Range 13, East of the Third Principal Meridian described as follows: Commencing at a point in the West line of lot 3 in said Keeney Industrial District, being the East line of North Monitor Avenue, 343.78 feet North of the South line of lot 4 in said Keeney Industrial District; thence North along the East line of North Monitor Avenue a distance of 160 feet; thence East along a line drawn parallel with and 503.78 feet North of the South line of said lot 4, a distance of 358.03 feet to its intersection with the Southerly right of way line of the land conveyed to Chicago, Milwaukee, St. Paul and Pacific Railroad Company by deed dated October 4, 1932 and recorded November 9, 1932 as document 1162537; thence South Easterly along said right of way line, being a striight line, a distance of 80.99 feet; thence continuing south Easterly along said right of way line, being a curved line convexed South Westerly and having a radius of 467.06 feet, a distance of 105.24 feet (arc) to its intermediation with a line drawn parallel with and 343.78 feet North of the South line of lot 4 aforesaid; thence West slong said parallel line a distance of 450.99 feet to the place of beginning;
