Borrower shall pay, or cause to be paid, when due and payable all taxes, assessments, water charges, sewer charges, license fees and other charges—against or in connection with the Property and shall, upon request, promptly furnish to Lender duplicate receipts. - 9. Sorrower Not Released; Forbeanance By Lender Not a Walver. Extension of the time for payment or modification of amortization of the sums necured by this Security Instrument granted by Lender to any successors in interest of Borrower shall not operate to release the Hability of the original Borrower or Borrower's successors in interest.
