THAT, WHEREAS, effective March 8, 1991, the Office of Thrift Supervision (OTS) by Order Number 90-136, ordered Alexander Hamilton Savings and Loan Association of Paterson, Paterson, New Jersey (Alexander Hamilton) closed and appointed the Resolution Trust Corporation (RTC) as its sole receiver for the purpose of liquidation;

WHEREAS, subsequent to the said transfer of the assets and certain liabilities of Alexander Hamilton to Alexander Hamilton Federal, the OTS, also by Order Number 90-136, appointed the RTC as conservator of Alexander Hamilton Federal and the RTC as Conservator succeeded to all of the rights, titles, powers and privileges of Alexander Hamilton Federal; and

WHEREAS, on September 12, 193%, by Order Number NE91-R025, the OTS replaced the RTC as conservator of Alexander Humilton Federal with the RTC as receiver of Alexander Hamilton Federal (acting in such capacity, the "Receiver") for the purpose of liquidation, and the Receiver has succeeded to all of the rights, titles, powers and privileges of Alexander Hamilton Federal to include all interests in, to and under that certain MORTGAGE dated MAY 5, 1977 executed by AARON R. BELL AND COREAN BELL, HIS WIFE, as Mortgagor(s), to MORTGAGE ASSOCIATES, INC., as Mortgages, for the principal sum of \$22,650.00, and recorded MAY 10, 1977 in the office of the Recorder of COOK County, State of ILLINGIS, in Book at Page, as Document No. 23919808, and covering the property described in Exhibit A attached.
