AN ORDINANCE AMENDING A PLANNED UNIT DEVELOPMENT AND GRANTING A SPECIAL USE PERMIT FOR A NON-COMMERCIAL ANTENNA STRUCTURE

WHEREAS, the President and Board of Trustees of the Village of Arlington Heights has heretofore, on August 7, 1989, passed and approved Ordinance Number 89-063 amending a planned unit development for the property located at 1975 East Davis Street, Arlington Heights, Illinois, to allow construction of a one-story building; and

WHEREAS, on October 14, 1992, the Plan Commission of the Village of Arlington Heights, in Project Number 92-031, conducted a public herring on a request to amend the planned unit development and granting a special use permit to allow the installation of a non-commercial antenna structure in a Public Land District; and

WHEREAS, the President and Board of Trustees have considered the report and recommendations of the Plan Commission and have determined that approval of said amendment to the Planned Unit Development, subject to certain conditions, would be in the best interests of the Villian of Arlington Heights,

NOW, THEREFORE, BE LT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION ONE: The Planned Unit Development for property logally described as:

That part of the Lot "D" in Kirchoff's Subdivision hereinafter described (except that part dedicated for streat by Document No. 10945013), lying East of the West line of the East 1/2 of the Southwest 1/4 and East of the West line of the East 1/2 of the North West 1/4 and North of the South line of the North 1/2 of the North East 1/4 of the South West 1/4 in Section 33, Township /2 North, Range 11 East of the Third Principal Meridian, said Kirchoff's Subdivision being a subdivision of pret of Section 33, Township 42 North, Range 11 East of the Third Principal Meridian, and parts of Sections 10 and 13, Township 41 North, Range 11 East of the Third Principal Moridian.
