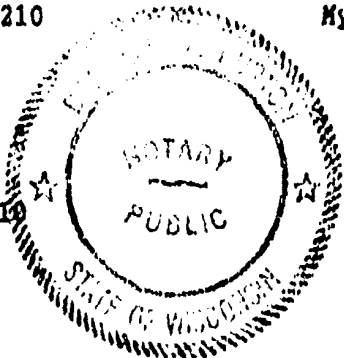

NORTH 89 DEGREES 42 MINUTES 45 SECONDS WEST, ALONG THE NORTH LINE OF
