WHEREAS. The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of public alleys described in the following ordinance; now, therefore.

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. That all that part of the east/west 18 foot public alley and all of the north/south 18 foot public alley lying south of the south line of Lots 1 to 7, both inclusive; lying north of the north line of Lot 11; lying east of the east line of Lot 8; and lying west of the west line of Lots 11, 12 and 13 all in Block 1 in B. Lombard's Subdivision of the north part of Lot 13 in the Assessor's Division of that part of Block 1 in (V. J. Hamilton's) Subdivision of the east 501.62 feet of the north 1,622 feet of the west half of the east half of the northwest quarter of Section 18, Township 33 North, Range 14 East of the Third Principal Meridian; said public alleys ligrein vacated being

further described as all of the east/west 18 foot public alley south of West Madisca Street and running west from South Hoyne Avenue together with all of the north/south 18 foot public alley west of South Hoyne Avenue and running north from the east/west 20 foot public alley all in the block bounded by West Madison Street, West Monroe Street, South Leavitt Street and South Hoyne Avenue as colored in red and indicated by the words "To Be Vacated" on the drawing hereto attached, which drawing for greater certainty, is hereby made a part of this ordinance, be and the same are hereby vacated and closed inasmuch as the same are no longer required for public use and the public interest will be subserved by such vacations.

SECTION 2. The vacations herein provided for are made upon the express condition that within 90 days after the passage of this ordinance, the City of Chicago (Department Of General Services) shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps.

SECTION 3. This ordinance shall take effect and be in force from and after its passage.
