#### FIRST AMENDMENT TO THE DECLARATION OF CONDONINIUM FOR THE WINDSOR WEST CONDONINIUM ASSOCIATION

This document is recorded for the purpose of amending the Declaration of Condominium (hereafter the "Declaration") for Windsor West Condominium Association (hereafter the "Association"), which Declaration was recorded on the 31st day of July, 1973, in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "\", which is attached hereto and made a part hereof.

This Pmendment is adopted pursuant to the provisions of Paragraph M. of the aforesaid Declaration. Said Article provides that this Amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, Migned and acknowledged by the members of the Board of Managers (hereafter the "Board") and by the owners having at least seventy-five percent (75%) of the total ownership of all Units, and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgages, having bona fide liens of record against any Unit Ownership, not less than 10 days prior to the date of such Amendment.

#### RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the easements, restrictions and covenants contained therein; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

WHEREAS, the following amendment has been approved in writing by the signatures of the Board and 75% of the Owners, in compliance with Article 17 of the Declaration, and due notice having been provided to all mortgagees holding bona fide liens of record against any unit ownership.

NOW, THEREFORE, the Declaration of Condominium for Windsor West Condominium Association is hereby amended in accordance with the text which follows (Additions in text are indicated by underline; deletions by strike-outs):

1. Paragraph 8(b) is amended as follows: 8(b) The direction and administration of the property shall be vested in a Board of Managers (herein referred to as the "Board"), consisting of five three persons who shall be elected in the manner hereinafter

Each member of the Board shall be one of the unit provided. owners; provided, however, that in the event a unit owner is a corporation, partnership, trust or other legal entity other than a natural person or persons, then any shareholder, officer or director of such corporation, partner of such partnership, beneficiary or individual trustee of such trust, or manager of such other legal entity, shall be eligible to serve as a member of the Board.

- This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- Except to the extent expressly set forth hereinabove, the isia Or Cook County Clerk's Office remaining provisions of the Declaration shall continue in effect without change.
