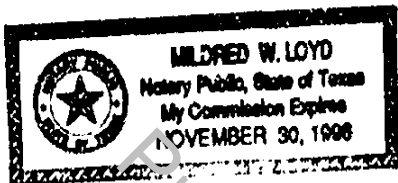

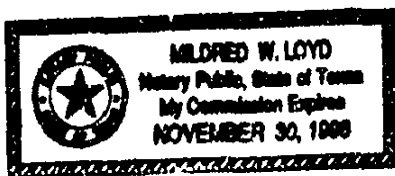

LEGAL DESCRIPTION

That part of the South East 1/4 of Section 26, Township 41 North, Range 13 East of the Third Principal Meridian, described as follows: commencing at a point in the South line of said Section 26, which is 660 feet West of the South East of said Section; and running thence West along said Section line for a distance of 856.85 feet to a point which is 460 feet East of the West line of the South 1/2 of the East 1/2 of the West 1/2 of said South East 1/4 of said Section 26 (measured along said section line); thence North parallel to said West line a distance of 500 feet to a point; thence East parallel to said South line of said Section 26 a distance of 856.28 feet to the point of intersection of said parallel line with a line which is 660 feet West of (measured on the South line of said Section) the East line of said Section 26; thence South on said last described line a distance of 500 feet to the place of beginning (except the part falling in street), in Cook County, Illinois.
