#### ARTICLE SEVEN OTHER PROVISIONS

Paragraph 1: All shares of the common stock of the corporation presently authorized shall be Section 1244 stock, issued pursuant to a plan within the meaning of Section 1244 of the Internal Revenue Code of the United States. Execution of a subscription agreement by a subscriber shall constitute his agreement to such plan, which is that the original capital of this corporation shall not exceed \$ 1,000,000.00

Paragraph 2: The holders of shares of each and every class and series in this Corporation shall not be entitled to cumulative voting rights in the election of Directors of this Corporation in any and all circumstances.

Paragraph 3: In furtherance and not in limitation of the powers conferred by the Business Corporation Act of 1983, the Board of Directors of the corporation is expressly authorized to provide indemnification to the full extent permitted by the Act. it being the policy of the corporation to safeguard its directors, officers and employees from expense and liability for actions they take in good faith in furtherance of the interests of the h hareh. County Clerk's Office corporation and its whareholders.
