WHEREAS, the Bank has loaned to the Borrower the sum of \$168,000.00 (the "Lean"), as evidenced by a note dated November 2, 1982 ands by the Borrower and payable to the Bank (the "Note") which has an outstanding orincipal balance as of the effective date hereof of \$108,189.75; and

WHEREAS, in addition to the Note, the Borrower has executed or chused to be executed and delivered to the Bank certain other documents which provide for, secure repayment of, or otherwise relate to, the Loan, including but not limited to a certain Trust Deed and certain Assignment of Rents dated November 2, 1982 which trust deed and assignment of rents were duly recorded on November 20, 1982 as document numbers 26407445 and 26407446, respectively, Modification Agraement dated November 30, 1987, was duly recorded on January 19, 1988 as document number 88025875 and Second Modification Agraement dated August 10, 1988, was duly recorded on September 30, 1988 as document number 88451289, mortgage or instrument in the nature of a mortgage ("Mortgage") constituting a lion upon the property legally described upon Exhibit A together with all improvements thereon ("Premises") (all documents collectively referred to as the "Loan Documents"); and

WHEREAS, for convenience, the signator of the Mortgage or instrument in the nature of a mortgage is referred to as "Mortgagor"; and

WHEREAS, under the terms of the Loan Documents the Loan is due and payable in full on December 10, 1992 ("Maturity Date"); and

WHEREAS, the Borrower and any Guarantor and the Bank wish to enter into this Agreement in order to smend the terms of the Loan, the Mortgage and other Loan Documents as provided herein and to set forth certain additional agreements as also provided herein;

NOW, THEREFORE, in consideration of the premises, the covenants and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- I. Incorporation of Recitals. The above and foregoing recitals are incorporated inco and made a part of this Agreement.
- 2. Extension of Existing Manurity Date. The Existing Maturity Date is hereby extended from December 10, 1992 to December 10, 1997 ("Maturity Date").
- 3. Modification of Mortgage. It is specifically agreed that the Mortgage is hereby amended and modified effective as of the date of its original recording to provide for the addition of the following:

"Nothing herein to toa contrary withstanding, this Mortgage has been given, in part, to secure (i) the payment when and as due and payable of the principal sum of and interest on the Note, (ii) the payment of all other indebtedness which this fortgage secures pursuant to its terms or which is payable under the terms of the Note, (111) any debt of the mortgager to the mortgagee and any debt of any guaranter to the mortgagee, (iv) the performance and observance of the covenants and agreements contained in and the payment of all obligations and liabilities of the mortgager under this Mortgage, the Note and the other Loan Documents, and (v) any extensions, refinancings, renewals, modifications, replacements or amendments of any of the foregoing matters in (1), (ii), (iii) and/or (iv), and the Mortgagor does by these presents grant, transfer bargain, set over, remise, release, assign, alien, warrant, pladge, sell, convey, and mortgage unto the mortgages, its successors and assigns forever, the real estate described in Exhibit A attached hereto and made a part hereof together with all improvements thereon ("Premises") and all of the mortgagor's estate, right, title, and interest therein."

- A. Notice of Default. The giving of any notice, or the granting of any right to cure any breach of the terms, provisions or obligations under any of the Loan Documents, to the extent expressly permitted under the Loan Documents, if at all, shall not be a condition precedent to the existence of a default; such default shall exist as of the data of such breach or violation of any term, provision or obligation under any of the Loan Documents, regardless if any required notice is given.
- 5. Event of Default. Nothing herein or in any Loan Document to the contrary, any breach or default of any term, condition, representation, warranty or covenant of this Agreement shall constitute and be construed as an event of default under each and every Loan Document; and, the occurrence of any event of default under any other Loan Document shall constitute and be construed as an event of default under this Agreement.
- 6. Terms of the Losn shall be as follows:
 - a. Commending on January 10, 1993 and continuing on the 10th day of each month thereafter payments of \$1,090.00 including principal and interest calculated at the rate of 8.75% per annum and computed on the basis of a year consisting of 360 days and charged for the actual number of days elapsed within the period for which interest is being charged, with a default rate of 11.75% per annum for the remaining term of the loan. Final payment of all outstanding principal and accrued interest, if not somer paid, will be due and payable on December 10, 1997. This is a Balloon Note and on the Maturity Date a Substantial Portion of the Principal amount of this note will remain unpaid.

b. Other:

- 1. Late Charges. The Bank may impose for any month in which the monthly payment is received more than fifteen (15) days after its due date, a late charge of five percent (5%) of the amount of the monthly payment due.
- 2. Bank's Right of Setoff. The Bank may, at any time hereafter, without notice, appropriate and apply toward the payment of the principal obligation under this Loan, whether due or not, any moneys, credits or other property belonging, individually or collectively, to the Borrower and any Guarantor, as hereinafter defined, in the possession or under the control of the Bank, as well as any indebtedness (whether then due or not then due) of the Bank to the Borrower however created or arising, including, but without limitation to, any and all balances, credits, deposits, accounts, or moneys of the Borrower, and the Bank is hereby given a first or prior

Lien upon such moneys, credits, indebtedness and other property; and the Bank may exercise none or any one or more of the foregoing options.

- The Borrower hereby requests and 3. Loan Expenses. authorizes the Bank to make advances for payment and reimburgement of all charges, costs and expenses incurred by the Bank in connection with this Agreement, including but not limited to (i) any points, loan fees, service charges or other fees due to the Bank inconnection with this Agreement; (ii) all examination, survey, environmental audit expense, eserow, filing, search, recording and registration fees and charges; all documentary stamp and other taxes and charges imposed by law on the issuance or recording of any of this Agreement; all appraisal fees; all title, canualty, liability, payment, performance or other insurance or bond premiums; and all fees and disbursements of all professionals, including legal changed engaged by the Bank in connection with this Agresment.
- 4. No Interest Payable on Reserve or Escrow Advounts. No interest shall be paid by the Bank for the benefit of the Berrower, Mortgagor or any Guarantor upon any Funds deposited with and held by the Bank for real estate taxes and assessments, insurance, or for any other Reserve or Escrow Addounts which the Bank may require.
- 5. Prepayment Premium. The Sorrower may at any time prepay the principal obligation under this Loan, in whole or in part, provided Borrower page a prepayment premium equal to the aggregate of three percent (3%) of the amount due to the Bank at the time of most prepayment through December 1993 with said penalty applining one-half of one percent (1/2%) annually thereafter until maturity and defined more fully in the following schools:

7. Current Representations And Warranties. To Induce the Bank to enter into this Agreement, the Borrower, Mortgagor and/or Guarantor hereby represents and warrants to the Bank as follows:

- a. Financial Statements. The most recent financial statements provided to the Bank fairly present the financial condition at the date thereof and the results of operations of the Premises for the period(s) covered thereby.
- b. No Befault. No default or event of default under the Note or the Loan Documents has occurred and is continuing, and no event has occurred and is continuing that, with the giving of notice or passage of time or both, would constitute such a default or event of default.
- c. Continued Accuracy. Each and every representation and warranty made by the Borrower, Mortgagor and/or Guarantor in favor of the Bank in connection with the Loan remains accurate in all respects, subject only to changes expressly permitted by the Bank.
- Reaffirmation. To the extent any term(s) or condition(s) in the Note or any of the Loan Documents shall contradict or be in conflict with the amended terms of the Loan as sat forth herein, such terms and conditions are hereby deemed modified and amended accordingly, upon the effective date hereof, to reflect the terms of the Loan as so amended herein. All terms of the Note and the Loan Documents, as amended hereby, shall be and remain in full force and effect and shall constitute the ingal valid, binding and enforceable obligations of the Borrower to the Bank. Upon the effective date hereof, the Borrower herein restates, ratifies and reaffirms each and every term and condition set forth in the Note and the Loan Documents as amended herein.
- 9. Absence Of Claim. To further induce the Bank to enter into this Agreement, the Borrower hereby acknowledges and agrees that, as of the date hereof, there exists no right of offset, defense, counterclaim or objection in favor of the Borrower as against the Bank with respect to the Borrower's obligations to the Bank.
- Waivers. To the extent permitted by applicable law, the Borrower, Mortgagor and any Guarantor shall not and will not apply for or avail themselves of any appraisement, valuation, redemption, stay, extension, or exemption laws or any so called "moratorium laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of the Mortgaga, out hereby waives the benefit of such laws. The Borrower, Mortgagor and any Guerantor, for themselves and all who may claim through or under it, waives any and all right to have the property and estates comprising the Premises marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Premises sold as an entirety. The Borrower, Mortgagor and any Guarantor hereby waives any and all rights of redesption from sale under any order or decree of foreclosure, pursuant to rights havein granted, on behalf of the Borrower, Mortgagor and any Guarantor, the trust estate, if any, and all persons beneficially interested therein, if any, and each and every person acquiring any interest in or title to the Premises described herein aubsequent to the date of this Agreement, and on behalf of all other persons to the extent permitted by law. - il. Environmental And Financial Covenants. To further induce the Bank to enter into this Agreement, in addition to the covenants and agreements of the Borrover set forth in the Note and the other Loan Documents, the Borrower and any Guarantor agree with the Bank as follows:
 - II. Hezardous Material Regulations Compliance.
 - a. Representations and Warranties. The Borrower and any Ouarantor represent to the Bank that:

Materials (as defined below), on, from or affecting any property given as security to the Bank for repayment of the Loan (hereinafter the "Premises") in any manner which violates federal, care or local laws, ordinances, rules, regulations or policies governing the use, storage, treatment, transportation, manufacture, refinement, handling, production or disposal of desardous Materials and, to the best of the Borrower's and any Cuarantor's knowledge, no prior owner of the Premises or any existing or prior tenant, or occupant has used Hazardous Materials on, from or affecting the Premises in any manner which violates federal, state or local laws, ordinances, rules, regulations or policies governing the use, storage, treatment, transportation, manufacture, refinement, handling, production or disposal of Hazardous Materials;

Neither the Borrower nor any Guarancor has ever received any notice of any violations (and is not rware of any existing violations) of federal, state or local laws, ordinances, rules, regulations or policies governing the use, storage, treatment, transportation, manufacture, refinement, handling, production or disposal of Hazardous Materials ar the Premises and, to the best of the Borrower's and any Granantor's knowledge, there have been no actions commenced or threatened by any party for noncompliance which affects the Premises;

The Borrower and any Guarantor shall keep or cause the Premises to be kept free of Hazardous Materials except to the extent that such Hazardous Materials are stored and/or used in compliance with all applicable federal, state and local laws and regulations; and, without limiting the foregoing, neither the Borrower nor any Guarantor shall cause or permit the Premises to be used to generate, manufacture, refine, transport, treat, store, handle, dispose of, transfer, produce, or process Hazardous Materials, except in compliance

with all applicable federal, state and local laws and regulations, nor shall the Borrower or any Guarantor cause or permit, as a result of any intentional or unintentional act or omission on the part of Borrower or any tenant, subtenant or occupant, a release, spill, leak or emission of Hazardous Materials onto the Premises or onto any contiguous property;

The Borrower and any Guarantor shall conduct and complete all investigations, including a comprehensive environmental audit, studies, sampling, and testing, and all remedial, removal and other actions necessary to clean up and remove all Hazardous Materials on, under, from or affecting the Premises as required by all applicable federal, state and local laws, ordinances, rules, regulations and policies, to the satisfaction of the Bank, and in accordance with the orders and directives of all federal, state and local governmental auditrities. If either the Borrower or any Guarantor fails to corduct an environmental audit required by the Bank, then the bank may at its option and at the expense of the Borrower, conduct such audit.

Indomnification. Subject to the limitations set forth below, the Borrower and any Guarantor shall defend, indemnify and hold harmless the Bank, Its employees, agents, officers and directors, from and equinst any claims, demands, penalties, fines, liabilities, settlements, damages, costs or expenses, including, without Hallation, attorney's and consultant's fees, investigation and laboratory fees, court costs and litigation expenses, known or unknown, contingent or otherwise, arising out of or in any way related to (i) the presence, disposal, release or threatened release of any Hazardous Materials on, over, under, from or affecting the Premises or the soil, water, vegetacton, buildings, personal property, persons or animals; (11) any personal injury (including wrongful death) or property damage (real or personal) arising out of or related to such Hazardous Materials on the Premises; (111) any lawsure brought or threatened, settlement reached or government order relating to such Hazardous Materials with respect to the Premises, and/or (Iv) any violation of laws, orders, regulations, requirements or domands of government authorities, or any portoles or requirements of the Bank, which are based upon or in any way related to such Hazardous Materials used in the Premises. The indemnity obligations under this paragraph are specifically limited as follows:

Neither the Borrower nor any Guarantor shall have any indemnity obligation with respect to Hazardous Materials that are first introduced to the Premises or any part of the Premises subsequent to the date that the Borrower's interest in and possession of the Premises or any part of the Premises

shall have fully terminated by foreclosure of any Mortgage given to the Bank or acceptance by the Bank of a deed in lieu of foreclosure;

Neither the Borrower nor any guarantor shall have any indemnity obligation with respect to any Hazardous Materials introduced to the Premises or any part of the Premises by the Bank, its successors or assigns.

The Borrower and any Guarantor agree that in the event any Mortgage given to the Bank is foreclosed or the Borrower tenders a deed in lieu of foreclosure, the Borrower and any Guarantor shall deliver the Premises to the Bank free of any and all Hazardous Materials which are then required to be removed (whether over time or immediately) pursuant to applicable federal, state and local laws, ordinances, rules or regulations affecting the Premises.

- For purposes of this Agreement the term Definitions. ¢. "Hazaroous Materials" includes, without limitation, materials, flammable explosives, radioactive materials, hexardous wastes, hazardous or toxic substances or related materials defined in the Comprehensive Environmental Response, Compagnation and Liability Act of 1980, as amended (42 U.S.C. Section 9501, et. seq.), the Hazardous Materials Transportation Act as amended (49 U.S.C. Sections 1801, et. seq.), the Resource Convervation and Recovery Act, as amended (42 U.S.C. Section 6901. et. seq.) and in the regulations adopted and publications promulgated pursuant thereto, or any other federal, state or lauri governmental law, ordinance, rule or regulation.
- Additional Obligation. The provision of this paragraph shall đ. be in addition to any and all other obligations and liabilities the Borrower and any Guarantor may have to the Bank under this Agreement, the Loan Documents, or by law, and shall survive: (i) the repayment of all sums and for the debt; (ii) the antimfaction of all of the other obligations of the Borrower and any Guarantor in any Hortgage and under any Loan Document; (iii) the discharge of any Mortgage given to the Bank; and (Iv) the foreclosure of any Mortgage or (creptance of a deed in lieu of foreclosure. Notwithstanding anything to the contrary contained in this Agreement, it is the intention of the Borrower and any Guarantor and the Bank that the indemnity provisions of this paragraph shall only apply to an action commended against any owner or operator of the Premises in which any interest of the Bank is threatened or any claim is made against the Bank for the payment of money.

12. Maintenance Of Books And Records.

A. Maintenance Of Records. The Borrower, Mortgagor and/or any Guaranter shall keep and maintain or cause to be kept and maintained full and correct books and records showing in detail all aspects of the Premises and within ten (10) days after demand therefore to permit the Bank, during normal business hours; to examine and photocopy such books and records and all supporting vouchers and data, at any time and from time to time, on request at the Borrower's, Mortgagor's or Guaranter's offices, or at such other location as may be mutually agreed upon.

Furnish Records. The Borrower, Mortgagor and any Guarantor shall within ninety (90) days after the end of each fiscal or, where applicable, calendar year, furnish to the Bank year end financial statements relating to the Premises for such fiscal (of calendar) year, in reasonable detail, and in any event including such itemized statements υĚ raceipts disburations as shall enable the Bank to determine whether a breach or other default of this Agreement or the Loan Decuments then exists. Such financial statements shall be at the Borrover's expense and be prepared in accordance with generally accounted accounting principles and shall include a statement as to whether or not the Borrower, Mortgagor and any Guarantor has knowledge of any event or circumstance which constitutes or with the passage of time will constitute an event of default herounder or under any other document executed in connection with or in any way related to this Loan. The Borrower, Mortgagor and any Guaranton shall provide the Bank with all other income tem and financial information in the manner required under the other Loan Documents.

- c. Affidavit Of Leases. The Borrower shall furnish, together with the foregoing financial statements and at any time upon the Bank's request, a then current and accurate Affidavit of Lease(s) upon Mortgaged Premises and Estoppel certificate from each tenant to the Bank, in a form and with coceant as then required by the Bank which documents shall show and evidence all information and additional documents reasonably requested by the Bank.
- d. Reimbursement Of Expenses. In the event the Borrower, Mortgagor and any Guarantor fails to comply with any of the above requirements and the Bank shall pay expenses in connection with obtaining of any of said required documents, including payment of attorney's fees, all such monies paid shall be deemed and construed as additional indebtedness due by the Borrower to the Bank and secured by the Mortgage, and shall become due and payable by the Borrower to the Bank upon payment or disbursement by the Bank, without notice and with

interest thereon at the interest rate required under the Note to be paid in the event of a default by Borrower.

- 13. Additional Documentation. Borrower, Mortgagor and any Guarantor shall execute and deliver to Bank, or cause to be executed and delivered to Bank from time to time, immediately upon Bank's request, all documents, including changes to any of the existing documents, required by Bank as Bank reasonably deems necessary to protect its security in any existing collateral security for the indebtedness described above.
- 14. Understanding Of Consequences. Each party acknowledges that they have read this Agreement, that they fully understand its terms, provisions, and consequences; and, that the entry into this Agreement is voluntary, free from duress, fraud or undue influence of any kind.
- 15. Effective Date. This Agreement shall be and become effective and binding pursuant to its terms after execution as of the date first above written. It is understood and agreed that said date shall be the effective date even though that date may be a date other or different than the actual date of execution.
- 16. Illinois law 12 dovern. This Agreement and each transaction contemplated hereunder shall be desired to be made under and shall be construed and interpreted in accordance with the laws of the State of Illinois.
- 17. Construction. It is agreed that it is both the intent and the desire of the parties that wherever possible each provision of this Agreement shall be given a judicial construction and interpretation so as to be effective and valid under Illinois law, but if any provision of this Agreement shall be construed or prohibited by or determined invalid under the laws of the State of Illinois, such provision shall be ineffective to the extent of such prohibition or invalidity only, without invalidating the remainder of such provision or the remaining provisions of this Agreement.
- in connection with the administration and enforcement of this Agreement, any additional documentation required by Bank and any and all of the Loan Documents. Without limiting the generality of the foregoing, if the Bank employ counsel for advice or other representation with respect to any matter concerning the Borrower and any Guarantor, this Agreement, the Premises or any aspect of the Loan Documents or to protect, collect, lease, sell, take possession of, or liquidate any of the Premises, or to attempt to enforce or protect any rights of the Bank or obligations of Borrower or any other person, firm or corporation which may be obligated to Bank by virtue of this Agreement or under any of the Loan Documents, then all of the attorneys' fees arising from such services, and any expenses, costs and charges relating thereto, shall constitute an additional indebtedness owing by Borrower to Bank payable on demand and evidenced and secured by the Loan Documents.

- 19. Partial Invalidity. Any one or more phrases, sentences, sections or provisions of this Agreement which subsequently shall be deemed, construed or interpreted by a court of competent jurisdiction to be unenforceable, invalid or contrary to law, or the inclusion of which would effect the validity or legal enforceability of this Agreement, shall be of no force or effect; and, in such event each of the remaining provisions of this Agreement shall subsist and remain and be fully effective according to the tenor of this Agreement as though any such unenforceable, invalid or unlawful provision or provisions had never been included in this Agreement.
- 20. Modification. Neither this Agreement nor any provision hereof may be amend a waived, discharged or terminated orally, unless such is deemed unenforceable, invalid or contrary to law as provided above. Rather, any provision of this Agreement may be amended, waived, discharged or terminated only by a written instrument duly executed and acknowledged by each and every of the parties to this Agreement and by no other means.
- 21. Binding effect. The terms, provisions and conditions of this Agreement shall be binding upon and inure to the benefit of each respective party and their respective legal representatives, successors and assigns.
- 22. Cumulative Rights. Each right, power, and remedy herein conferred upon any party is cumulative and in addition to every other right, power, or remedy, express or implied, given according herein set forth or otherwise so existing may be exercised from time to time as often and in such order as may be deemed expedient by either party, and the exercise or the beginning of the exercise of one right, power or remedy stall not be a waiver of the right to exercise at the same time or thereafter any other right, power, or remedy; and no delay or emission of either party in the exercise of any right, power, or remedy according hereunder or arising otherwise shall impair any such right, power, or remedy, or be construed to be a waiver of any default, or acquiescence therein.
- 23. Non-Waiver. The failure to insist upon strict performance of any of the terms, covenants, obligations or conditions hereof shall not be deemed a waiver of any rights or remedies that any party may have and shall not be deemed a waiver of any subsequent breach or default in any such terms, covenants or conditions.
- 26. Notices.
