THIS MORTGAGE is dated as of <u>FEBRUARY 2, 1923</u>, and is executed by <u>JAMES PRYBYLO</u> (DIVORCED AND NOT SINCE REMARRIED) AND MICHAEL L. KERRIGAN (DIVORCED AND NOT SINCE REMARRIED).

(Borrower(s), the record owner of the Premises, as hereinafter defined in favor of COLE TAYLOR BANK, an Illinois banking corporation located at 850 West Jackson Boulevard, Chicago, Illinois (Lender).

WITNESSETH:

JAMES PRY 6Y LO (DIVORCED AND NOT SINCE REMARRIED) AND MICHAEL L. KERRIGAN (DIVORCED AND NOT SPICE REMARRIED).

If the party in foregoing blank is not Borrower, such other party is hereinafter referred to as ("Obligor") has executed a Promissory Note (Note") dated as of the date of this Mortgage, payable to the order of Lender, in the principal amount of: THR"/ SINE THOUSAND SIX HUNDRED DOLLARS (\$39,600.00).

Interest on the aggregate unpaid principal balance from time to time outstanding shall be payable on the <u>FIRST (1ST)</u> day of each <u>MONTH</u>, cor moreing, <u>APRIL 1ST</u>, 19_23, at the per annum rate of <u>Prime plus ONE AND ONE HALF PERCENT</u> (15.7%) in excess of the Prime Rate (defined below). Interest after Default or Maturity on the aggregate unpaid principal balance shall be at the per annum rate of four percent (4%) in the excess of the aforesaid rate.

The principal and interest of the Note are payable as follows: THRTY FIVE (35) MONTHLY payments of FOUR HUNDRED TWENTY FIVE ANND 70/100 P.O. LARS (\$425.70), principal including interest due on the FIRST (1ST) day of each MONTH, commencing on APL 1ST, 1993, and monthly thereafter until MARCH 1ST, 1996 ("Maturity") at which time the balance of unpaid principal and interest accrued shall be due and payable.

If the aforementioned interest rate mentions Lender's "Prime Bute", such prime rate means the prime rate as defined in the Note, or, if the Note contains definition of prime rate, then prime rate means the rate of interest established from time to time by Lender as its prime rate, and used by it in computing interest on those loans on which interest is established with relationship to the Lender's prime rate, at p. phown on the books and records of Lender, which prime rate will fluctuate hereunder from time to time concurrently with each change in Lender's prime rate, with or without notice to anyone.

Nothing herein contained shall be construed as defining "Prime Rate" as the real charged by Londer to its most credit-worthy customers. Interest on the outstanding principal balance of the Note shall be becreased to the rate of <u>FOUR PERCENT</u> (4%) in excess of the aforesaid rate then in effect, after maturity of the Note or upon default under the Note or this Mortgage. If any payment of interest or principal on the Note is not received as and when due, Borrower shall be charged a late fee as follows:


There shall be paid to the note holder a late charge of 5% for any payment not received by the cost holder within ten days after the herein payment is due.

To secure payment of the Indebtedness evidenced by the Note and the hereinafter defined liabilities, including, without limitation, future advances, if any, on the Note, prior to its express maturity date and in all events prior to <u>TWENTY</u> (20) years from the date hereof, to the same extent as if such advances were made on the date of the Note, Borrower's does by these presents CONVEY and MORTGAGE unto Lender, all of Borrower's estate, right, title and interest in the real estate situated, lying and being in the County of COOK, and State of ILLINOIS legally described as follows:

The foregoing items are and shall be deemed a part of the Premises and a portion of the scenic for the Liabilities as between the parties hereto and all persons claiming by, through or under them. Portions of the foregoing are goods which are or shall become fixtures on the Premises, and Borrower agrees that the filing of this Mortgage in the real estate records of Cook County, Illinois shall also operate, at the time of such filting, as a fixture filing in accordance with the provisions of the Uniform Commercial Code as adopted in the State of Illinois.

Further, Borrower does her by pledge and assign to Lender, all leases, written or verbal, rents, issues and profits of the Premises, including without limitation, all rents, issues, profits revenues, royalties, bonuses, rights and benefits now due, past due, or to become due and all deposits of money as advance rent or for security, under any and all present and future leases of the 're nises or any other agreement for the occupancy or use of all or any part of the Premises, together with the right, by a not the obligation, to collect, receive, demand, sue for and recover the same when due or payable, Borrower hereby a charizes Lender or Lender's agents to collect the aforesaid rents and revenues and hereby directing each tenant of the Premises to pay such rent to Lander or Lender's agents, Lender by acceptance of this Mortgage agrees, as a personal covenant applicable to Borrower only, and not as a limitation or condition hereof and not available to anyone oner than Borrower, that until a Default, as hereinafter defined, shall occur or an event shall occur, which under the terms hereof shall give to Lender the right to foreclose this Mortgage, Borrower may collect, receive and enjoy such evails. Borrower agrees that each tenant of the Premises shall pay such rents to Lender or Lenders agents on Lender's written demand therefore without any liability on the part of said tenant to inquire further as to the existence of a Default by Borrower or Obliger. Borrower hereby covenuats that Borrower has not performed, and will not perform, any acts or has not executed, and will not execute, any instruments which would provent Lender from or reising any rights pursuant to such rents or other amounts, that at the time of execution of this Mortgage there has been no anticipation or prepayment of the rent nor the Premises and that Borrower will not hereafter collect or accept payment of any rents of the Premises prior to the due dates of such rents.

Further, Borrower warrants, covenants and agrees as follows:

- 1. <u>Duty To Maintain Premises and Title to Premises</u>. Borrower shall (a) promptly repair restore or rebuild any buildings or improvements now or hereafter on the Premises which may become damaged or be destroyed; (b) keep the Premises in good condition and repair, without waste, and, except for this Mortgage area from any encumbrances, mechanic's tiens or other liens or claims for lien; (c) pay when due any indebtedness which may be secured by a lien or charge on the Premises, and upon request exhibit satisfactory evidence of the chemarge of such lien to Lender; (d) comply with all requirements of all laws or municipal ordinances with respect to the Premises and the use of the Premises; (e) refrain from impairing or diminishing the value of the Premises.
- 2. Taxes, Assessments and Charges. Borrower shall pay, when due and before any penalty attaches, all general taxes, special taxes, special assessments, water charges, drainage charges, sewer service charges, and other charges against the Premises. Borrower shall, upon written request, furnish to Londer duplicate paid receipts for such taxes, assessments and charges. To prevent Default hereunder Borrower shall pay in full, prior to such tax, assessment or charge becoming delinquent, under protest, in the manner provided by statute, any tax, assessment or charge which Borrower may desire to contest.
- 3. <u>Lenses</u>. Upon the request of Lender, Borrower shall deliver to Lender all original leases of all or any portion of the Premises, together with assignments of such leases from Borrower to Lender, which assignments shall be in form and substance satisfactory to Lender.

- 4. Condemnation. Any awards of damage resulting from condemnation proceedings, exercise of the power of eminent domain, or the taking of the Premises for public use are hereby transferred, assigned and shall be paid to Lender and the proceeds or any part thereof may be applied by Lender, after the payment of all of its expenses, including costs and attorney's fees, to the reduction of the indebtedness secured hereby and Lender is hereby authorized, on behalf and in the name of Borrower, to execute and deliver valid acquittances and to appeal from any such award.
- 5. Non-Exclusivity and Preservation of Remedies. No remedy or right of Lender hereunder shall be exclusive. Each right and remedy of Lender with respect to this Mortgage shall be in addition to every other remedy or right now or hereafter existing at law or in equity. No delay by Lender in exercising, or omission to exercise, any remedy or right accruing on Default shall impair any such remedy or right, or shall be construed to be a waiver of any such Default, or acquiescence therein, nor shall it affect any subsequent Default of the same or a different nature. Every such remedy or right may be exercised concurrently or independently, and when and as often as may be deemed expedient by Lender.
- 6. Insurance. Borrower shall keep all buildings and improvements now or hereafter situated on the Premises insured against loss or damage by fire, lightning, windstorm and such other hazard as may from time to time be designated by Londer, including, without limitation, flood damage, where Londer is required by law to have the loan evidenced by the Note so insured. Each Insurance policy shall be for an amount sufficient to pay the cost of replacing or repairing the buildings and improvements on the Premises and, in no event less than the outstanding principal amount of the Note; all policies shall be issued by companies satisfactory to Lender. Each insurance policy shall contain a lender's loss payable clause or endorsement, in form and substance satisfactory to Lender. Borrower shall deliver all insurance policies, including additional and ranc all policies, to Lender. In case of insurance about to expire, Borrower shall deliver to Lender renewal policies not less than ten days prior to the respective dates of expiration. Upon the occurrence of any event insured against by any of the aforementioned insurance policies, and the receipt of insurance proceeds by Lender, Lender shall, at its option, after payment of all of Lender's costs and expenses with respect thereto, including outside or in-house attorner a fees, apply such proceeds to the reduction of the Liabilities, in such order of application as Lender may determine
- 7. Expenses. Upon Default he oulder, and at any time during a suit to foreclose the lien of this Mortgage and prior to a sale of the Premises, Leider may, but need not, make any payment or perform any act required by Borrower hereunder in any form and planner deemed expedient by Lender, and Lender may, but need not, make full or partial payments of principal or interest on any encumbrances effecting the Premises and Lender may purchase, discharge, compromise or settle any tax lier or other lien or title or claim thereof, or redeem from any tax sale or forfeiture effecting the Premises or context any tax or assessment. All moneys paid for any of the purposes authorized in this Mortgage and all expenses paid of incurred in connection therewith, including outside or in-house attorney's fees, and any other monies advanced by Lender to protect the Premises or the lien thereof, plus reasonable compensation to Lender for each matter concerning which action therein authorized may be taken, shall be additional Liabilities and shall become immediately due and hay able without notice and with interest thereon at a per annum rate equivalent to the post maturity or post default (Action er is higher) interest rate set forth in the Note. Inaction of Lender shall never be considered a waiver of any right aperuing to Lender on account of any default hereunder.
- 8. No Inquiry for Expenses. If Lender makes any payment authorized by this Mortgage relating to taxes, assessments, charges or encumbrances, Lender may do so according to any bill, statement or estimate received from the appropriate public office without inquiry into the accuracy or validity of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 9. Environmental Warranties and Representations. Borrower warrants and represent to Lender that no release of any patroleum, oit or chemical liquids or solids, liquid or gaseous products or hazarlov, waste or any other pollution or contamination ("Environmental Contamination") has occurred or is existing on may portion of any Premises or, to the best knowledge of Borrower, on any other real estate now or previously owned, tease I, occupied or operated by Borrower or Obliger or with respect to Borrower's or Obliger's business and operations, on I neither Borrower nor Obliger has received notice, oral or written, from any source, of any of the following occurrences:
 - 9.1.1 any such Environmental Contamination;
- 9.1.2 that Borrower's or Obliger's business or operations are not in full compliance with requirements of federal, state or local environmental, health and safety statutes or regulations;
- 9.1.3 that Borrower or Obliger is the subject of any federal, state or local investigation evaluating whether any remedial action is needed to respond to any Environmental Contamination, alloged otherwise;
- 9.1.4 that any portion of the Premises or of any other property or assets of Borrower or Obliger, real or personal, is subject to any lien arising under any federal, state or local environmental, health and safety statutes or regulations.

- 9.2 Responsible Property Transfer Act. Borrower covenants warrants and represents to Lender that the Premises are not subject to the Responsible Property Transfer Act of 1988 of the State of Illinois (the "Act"), or, if the Premises are subject to the Act, Borrower has delivered to Lender a complete and accurate Disclosure Document required under the Act.
- 9.3 Environmental Covenants and Agreements. Borrower covenants and agrees, until all Liabilities are paid in full:
- 9.3.1 Borrower shall not cause or permit to exist any Environmental Contamination on any portion of the Premises or on any portion of any other real estate now or hereafter owned, leased or occupied or operated by Borrower or Obliger, or with respect to the business and operations of Borrower or Obliger.
- 9.3 2 Borrower shall immediately notify Lender of its receipt of any notice, oral or written, of the type described in Paragraph 9.1 of this Mortgage.
- 9.4 Environmental Indemnification. Borrower hereby indemnifies and holds Lender harmless from and against all losses, costs, claims, causes of action, damages (including special, consequential and punitive damages), and including in house or outside attorneys' fees and costs, incurred by Lender and in any manner related to or arising from the breach of any of the foregoing warranties, representations, covenants, agreements or Lender's becoming liable, in any manner whatsoever, under the Act or for any Environmental Contamination previously, now or hereafter existing or occurring on any portion of the Premises or on any other real estate previously, now or in the future owned, leased, occupied or operated by Borrower or Obligor occurring with respect to Borrower's or Obligor's business or operations, which indemnification shall survive the payment in full of the Liabilities.
- 9.5 Environment of Defaults. The Breach of any warranties, representations, covenants or agreements contained in Paragraph 9.1 though 9.4 of this Mortgage or the giving to Borrower or Obliger of any notice of the type described in Paragraph 9.1 of this Mortgage (regardless of whether any Environmental Contamination of the type described in Paragraph 9.1 of this Mortgage has occurred and regardless of whether Borrower has notified Lender of the receipt of any such notice) and entitle Lender to accelerate the maturity of all Liabilities, and all such Liabilities shall become immediately the reafter due and payable, and if payment thereof is not immediately made, Lender shall have all remedies stated in this bortgage or otherwise available to it.
- 9.6 <u>Environmental Provisions Bindor on Beneficiaries</u>. If Borrower is a land trustee, all warranties, representations, covenants and agreement container in Paragraphs 9.1 through 9.4 of this Mortgage shall also apply and refer to any beneficiaries of the land trust of which Borrower is trustee.
- 10. Default. Upon Default, at the sole option of Leader, the Note and any other Liabilities shall be come immediately due and payable and Borrower shall pay all expenses of Lender including in-house and outside attorney's fees and expenses incurred in connection with this Modgage and all expenses incurred in the enforcement of Lender's rights in the Premises and other costs incurred in connection with the disposition of the Premises. The term "Default" when used in this Mortgage meant (a) any one or note of the events, conditions or acts, if any, defined as a "Default" in the Note, all of which are hereby incorporated to reference herein, (b) the failure of Borrower or, if applicable, Obliger to pay the Note, in accordance with the terms of the Note, (c) the falsity of, or failure of Borrower or, if applicable, Obliger to comply with or to perform any representation, warranty, term, condition, covenant or agreement contained in this Mortgage, the Note or any assument securing any Liabilities, (d) the occurrence of any event, described in this or any other document, giving the der the right to accelerate the maturity of any of the Liabilities or constituting a default of any of the Liabilities; (r) if Borrower is a land trustee, the failure of any beneficiaries of the land trust of which Borrower is trustee to comply with or perform any covenant or agreement contained in any instrument securing the Liabilities.
- 11. <u>Due on Sale</u>. Notwithstanding any other provisions of this Mortgage, no sale, lower mortgage, trust deed, grant by Borrower of any encumbrance of any kind, conveyance, contract to sell, or transfer or the Premises, or any part thereof, or transfer or occupancy or possession of the Premises, or any part thereof small be made without the prior written consent of Lender. If Borrower is a land trustee, no sale, assignment, grant or an encumbrance of any kind, conveyance or contract to sell or transfer the Premises or any part thereof or all or any part of the beneficial interest in the land trust of which Borrower is trustee, or transfer or occupancy or possession of the Premises, or any part thereof, shall be made by the beneficiaries of such land trust without the prior written consent of the Lender.
- 12. <u>Definition of Liabilities</u>. "Liabilities" means all obligations of Borrower or Obliger or, if Borrower is a Land trustee, any beneficiaries of the land trust of which Borrower is trustee, to Lender for payment of any and all amounts due under the Note, this Mortgage and of any indebtedness, or contractual duty of every kind and nature of Borrower or Obliger or such beneficiaries or any guarantor of the Note to Lender, howsoever created, arising or evidenced, whether direct or indirect, absolute or contingent, joint or several, now or horsafter existing, due or to become due and howsoever owned, held or acquired whether through discount, overdraft, purchase, direct loan or as collateral, or otherwise. "Liabilities" also includes all amounts as described herein and all costs of collection, legal expenses and in-house or outside attorneys' fees incurred or paid by Lender in attempting the collection or enforcement of the Note or this Mortgage, or any extension or modification of this Mortgage or the Note, any guaranty of the Note, or any other indebtedness of Borrower or Obliger or the aforementioned beneficiaries or any guarantos of the Note to Lender, or in any legal proceeding occurring by reason of Lender being the mortgages

under this Mortgage or any extension or modification thereof or the payes under the Note or any extension or modification thereof including but not limited to any declaratory judgment action, or in the repossession, custody, sale, lease, assembly or other disposition of any collateral for the Note. Notwithstanding anything contained herein to the contrary, in no event shall the lien of the Mortgage secure outstanding Liabilities in excess of 200% of the original stated principal amount of the Note.

- 13. Foreclosure. When any of the Liabilities shall become due whether by acceleration or otherwise, Londor shall have the right to foreclose the tien of this Mortgage. In any suit to foreclose the lien of this Mortgage, there shall be allowed and included any additional indebtedness in the judgment of foreclosure, all expenditures and expenses which may be paid or incurred by or on behalf of Lender for outside or in-house attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stonographers' charges, publication costs and costs of procuring all abstracts of title, title searches and examinations, title insurance policies, Torrens Certificate, and similar data and assurances with respect to title as Lender may deem to be reasonably necessary either to prosecute the foreclosure suit or to evidence to bidders at any foreclosure sale. All of he foregoing items, which may be expended after entry of the foreclosure judgment, may be estimated by Lender. All expenditures and expenses mentioned in this paragraph shall become additional Liabilities and shall be immediately due and payable, with interest thereon at a rate equivalent to the post-maturity or post-default (whichever is higher) rate set forth in the Note or her in, when paid or incurred or paid by Lender or on behalf of Londer in connection with (a) any proceeding, including without limitation, probate and bankruptcy proceedings, to which Londor shall be a party, as plaintiff, claiment, defendant or otherwise, by reason of this Mortgage or any Liabilities; or (b) preparation for the commencement of any suit to collect upon or enforce the provisions of the Note or any instrument which secures the Note after default under the Note, whether or not actually commenced; or (c) preparations of the defense of any threatened suit or proceeding which might effect the Premises or the security hereof, whether or not actually commenced.
- 14. Proceeds of For Mosure. The proceeds of any foreclosure sale shall be distributed and applied in the following order or priority: first to be reasonable expenses of such sale; second, to the reasonable expenses of securing possession of the Premises of rore sale, holding, maintaining and preparing the Premises for sale, including payment of taxes and other governments' energies, premiums on hazard and liability insurance, management fees, reasonable outside or In-house attorneys fees, payments made pursuant to Section 15-1505 of the Illinois Mortgage Foreclosure Law or otherwise authorized in this Mortgage and other legal expenses incurred by Lender; third, to the satisfaction of claims in the order of priority adjudicated in the judgment of foreclosure, and with respect to the Liabilities, first to all items which under the terms of this Mortgage, constitute Liabilities secured by this Mortgage additional to that evidenced by the Note, with interest thereon as herein provided, second to interest remaining unpaid on the Liabilities evidenced by the Note, and there is no provided to the Liabilities evidenced by the Note, and the land trusted to the beneficiaries of the land trust of which Borrower is trustee, or as otherwise directed my the court.
- 15. Receiver. Upon, or at any time after the filing of a con plaint to foreclose this Mortgage, as otherwise permitted by the Illinois Mortgage Foreclosure Law, the court in which such suit is filed may appoint a receiver of the Premises, or may appoint the Lender as Mortgagee-In-Possession of the Premises. Such receiver, or Lender as mortgagee-in-possession, shall have power to collect the rents issues and profits of the Premises and shall also have all other powers which may be necessary or are usual for the protection, possession, control, management and operation of the Premises.
- 16. <u>Unavailability of Certain Defenses</u>. No actions for the enforcement of the lien or of any provision of this Mortgage shall be subject to any defense which would not be good and available to the party interposing the same in an action at law upon the Note.
- 17. <u>Inspection</u>. Lender shall have the right, but not the obligation, in its sole discretion, to inspect the Premises at all reasonable times and access thereto shall be permitted for that purpose. The for going does not relieve Borrower from any obligation under this Mortgage, the Note or any other instrument securing the Liabilities, to maintain the Premises.
- 18. Estoppel Statement By Borrower. Borrower shall, within ten (10) days of a written request therefore from Lender, furnish Lender with a written statement, duly acknowledged, setting forth the then outstanding balance of the Note and that there are no rights of set-off, counterclaim or defense which exist against such balance or any of the Liabilities.
- 19. Taxes and Insurance. On written request by Lender, Borrower shall pay to Lender on the day monthly installments of principal and/or interest are payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth (1/12) of the yearly taxes and assessments on the Premises, plus one-twelfth of yearly premium installments for hazard insurance, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof. The Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or state agency (including Lender if Lender it such an institution). Lender shall apply the funds to pay said taxes, assessments, and insurance premiums. Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower without charge, on Borrower's written request, an accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. Borrower hereby pledges the Funds as additional security for the payment of the Liabilities, and authorizes Lender to deduct from the Funds any past due Liabilities, without

prior notice to Borrower, whether or not a default has occurred. If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments and insurance premiums shall exceed the amount required to pay said taxes, assessments and insurance premiums as they fall due, such excess shall, if requested by Borrower, be either promptly repaid to Borrower or credited to Borrower's monthly installments of Funds, at Borrower's option. If the amount of the Funds held by Lender shall not be sufficient to pay taxes, assessments and insurance premiums as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within TEN (10) days from the date notice it mailed by Lender to Borrower requesting payment thereof.
