That said contractor is entitled to credits on account thereof as follows: \$4,166.59, leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of One Hundred Seventeen Thousand Two Hundred Seventy-Two and no/100 (\$117,272.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.




