4. That the parties were married on February 13, 1975 and the marriage was registered in the City of Las Vegas, County of Clark, State of Nevada;

5. That one child was born of the marriage, to wit: Jason E. Carlson, born July 2, 1980; no children were adopted; and, Respondent is not now pregnant;

6. That irreconcilable differences have arisen between the parties, which have led to an irretrievable breakdown in the marriage; efforts at reconciliation have failed; and future attempts at reconciliation would be impracticable and not in the best interest of the family;

7. That the parties have been living separate and apart as single persons since May 8, 1991; and that the parties have executed and filed with the Court a written stipulation to waive the two year statutory period of separation;

8. That the Respondent has proved the allegations of her Amended CounterPetition for Dissolution of Marriage by substantial, competent and relevant evidence; and a Judgment of Dissolution of Marriage should be entered herein.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. The Petition for Dissolution of Marriage is hereby granted and the parties are awarded a Judgment of Dissolution of Marriage; that the marriage heretofore alleged existing between the parties is hereby declared dissolved.

2. The Respondent is hereby awarded the sole care, custody, control and education of the minor child; Petitioner shall have reasonable and liberal visitation with the minor child.

3. Petitioner shall pay the monthly sum of \$240.00 per month as child support directly to the Respondent, payable \$120.00 on the first day of each month and \$120.00 on the 15th day of each month.

4. The marital residence, a parcel of real estate described as follows:

Lots 18 and 19 in Block 4 of the Ellsworth Subdivision in Section 25, Township 40, Range 12, East of the Third Principal Meridian, in Cook County, Illinois;

- f) Gold Optima Card, account number 3737-565505-34008, in the amount of \$910.70;

- i) Gottlieb Memorial Hospital, account number G10899078, in the amount of \$2,838.55; and,
- j) Promissory note held by George Garcia against Scott Carlson in the amount of \$3,000.00.

After the payment of all mortgages and liens, all sale settlement costs, and the above described marital debts, the residuary proceeds shall be distributed so that Respondent shall receive 65% of the remaining proceeds and Petitioner shall receive 35% of the remaining proceeds. However, from his 35% share of the proceeds, Petitioner shall pay the sum of \$7,172.00 to the Respondent in satisfaction of child support arrearages, and he shall pay the sum of \$617.50 to Robert G. White, attorney for Respondent, as previously ordered by the Court.

a) Consumers Illinois Water Company, account number 67061055-01, in the amount of \$211.92; and,

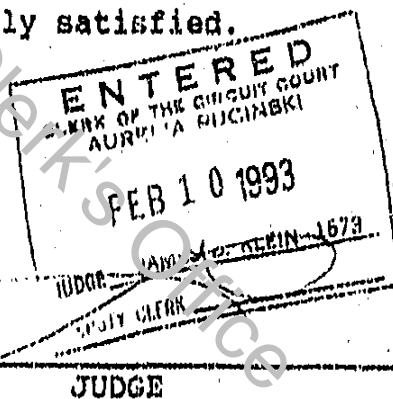
b) Commonwealth Edison, account number HR42-JL-1318-B, in the amount of \$31.50.

6. In addition to the above, each of the parties shall have as their own personal property the property currently in their respective control, free from any claim from the other party, and each of the parties shall be solely responsible for the debts that they have incurred from the date of their separation on May 8, 1991 and shall hold the other harmless thereon.

7. Petitioner shall be hereafter barred from any future claims against Respondent, including all claims of maintenance. Claims of maintenance which may be made by Respondent against Petitioner shall be reserved for the future determination of the Court.

8. The Court retains jurisdiction of the parties and of the subject matter until this Judgment shall be fully satisfied.
