ADDITIONAL CONVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON THE NEVERSE SIDE OF THIS MORTVIAGE AND INCORPORATED THEREIN BY REFERENCE.

- 1. Mortgagors shall (1) promptly espair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become demaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other inne or claims for iten not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises asperior to the lien hereof and upon exquest exhibit satisfactory evidence of the discharge of such prior lien to Mortgage or to holder of the contract; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of inv or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- Mortgagons shall pay before any pensity attaches all general taxes and shall pay special taxes, special taxes assessments, water charges, eswer correspondent the premises when due, and shall upon written request, furnish to Mortgages or to holders of the contract duplicate receipts therefor. To prevent default becomes Mortgagors shall pay to full under protest, in the manner provided by statists, any tax or assessment which Mortgagors may desire to contract.
- 3. Mortgagors shall keep all buildings and improvements now and bereafter situated on said premises insured against beaut damage by fire, lightening small windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the hidd-indicass accurate hereby, all in companies satisfactory to the holders of the contract, under insurance policies payable, in case of loss or damage, to Mortgages, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shell deliver all policies including additional and renewed policies to holder of the contract and in case of insurance about to expire, shell deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Mortgages or the holder of the contract may, but need not, make any payment or perform any act horeinhefore required of Mortgagors in any form end manner deemed appellent, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, it any, and purchase, discharge, compromise or settle any tax lies or other prior lies on title or claim thereof, or redeem from any tax sale or forfetture, affecting said premises or contest any tax or as reasonent. All moneys paid for any of these purposes berein authorized and all expenses paid or incurred in connectical therewith, including attorneys feek, and any other moneys advanced by Mortgagors or the holders of the contract to protect the mortgaged premises and the iten hereof, shall be so much additional indebtedners accured hereby and shall become immediately due and payells without notics. Inaction of Mortgagors or holders of the contract as a visiver of any right account of any default hereunder on the part of the Mortgagors.
- 5. The Mortgages or the holder of the contract hereby secured making any payment hereby authorized relating to taxes and assessments, may do so according to any bill, statement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tall in or title or claim thereof.
- 6. Mortgagors shall pay each item of indel (of ness herein mentioned, when due according to the terms hereof. At the option of the holder of the contract, and without notice to the Mortgagors, all unpaid in the contract by the Mortgage shall notwithstanding anything in the contract or in this Mortgage to the contrary, become due and payable (a) in the case of defend in making payment of any instalment on the contract which default shall continue for 30 days, or (b) when default shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 7. When the indebtedness hereby secured shall become do whether by acceleration or otherwise, Mortgages shall have the right to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgages or holder of the contract for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such shotzects of title, title searches and examinations, guarantee policies. Torrent explicates and similar data and assurances with respect to title to Mortgages or holder of the contract may deem to be evasousably necessary other to prosecute so it is it to evidence to hidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expenses of the nature in this paragraph mentioned shall become so much admirental indebtedness secured hereby and immodiately due and payable, when paid or incurred by Mortgages or holder of the contract in connection with (a) any proceeding, including probate and bankruptcy proceedings, to which either of them shall be a party, either as plaintiff, claiment or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparations for the commencement of any auit for the foreclosure hereof after accrual of such light to foreclose whether or not actually commenced or (c) preparations for the defense of any throatened suit of the foreclosure hereof after accrual of such tight to foreclose whether or not actually commenced.
- 8. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mention; a in the proceeding paragraph beroof, second, all other items which under the terms beroof constitute secured indebtedness additional to that evidenced by the contract, that, all other indebtedness, if any, remaining unpaid on the contract, fourth, any overplus to Mortgagors, their heirs, legal representatives or sesting as their right, may appear.
- D. Upon, or at any time after the filing of a bill to foreclose this mortgage the court in which any a bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale without notice, without regard to the solvency of insolvency of Mortgagers at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied. - 10. No action for the enforcement of the lien or any provision bersof shall be subject to any defense which would not be good at do a stable to the party interposing same in an action at law upon the contract hereby secured.
- 11. Mortgages or the holder of the contract shall have the right to inspect the premises at all reasonable times and access there or hall be premitted for that purpose.
- 12. If Mortgagon shall sell, assign or transfer any right, title or interest in said premises, or any portion thereof, without the written consent of the holder of the contract secured hereby, holder shall have the right, at holder's option, to delcare all unpaid indebtedness secured by this mortgage to be immediately due and payable, snything in said contract or this mortgage to the contrary notwithstanding.
