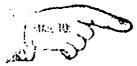

ASSIGNMENT OF RENTS

THIS ASSIGNMENT OF FAMES IS DATED FEBRUARY 19, 1993, between MICHAEL A. DENOFRIO, VIRGINIA DENOFRIO and MARK DENO, Whose address is 1227 WEST FLOURNOY ST., CHICAGO, IL 60607 (referred to below as "Grantor"); and MARONAL REPUBLIC BANK OF CHICAGO, whose address is 1201 WEST HARRISON ST., CHICAGO, IL 60607 (referred to below as "Lender").

ASSIGNMENT. For valuable consideration, Grantor assigns and conveys to Lender all of Grantor's right, title, and interest in and to the Rents from the following described Property located in Cook County, State of Illinole:

DEFINITIONS. The following words shall have the following meanings when used in this Assignment. Terms not otherwise defined in this Assignment shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean amounts in lawful money of the United States of America.

Assignment. The word "Assignment" means this Assignment of Rents between Gruntor and Lender, and includes without limitation all assignments and security interest provisions relating to the Ranks.

Event of Default. The words "Event of Default" mean and include any of the Events of Default of Original The words "Event of Default"

Grandov. The word "Grandor" means MICHAEL A. DENOFRIO, VIRGINIA DENOFRIO and MARK DENOFRIO.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any under the expension of Grantor or expenses incurred by Lender to enforce obligations of Grantor under the Assignment, together with interest on such amounts as provided in this Assignment.

Lender. The word "Lender" means NATIONAL REPUBLIC BANK OF CHICAGO, its successors and assigns.

Note. The word "Note" means the promissory note or credit agreement dated February 19, 1993, in the original purpled amount of \$180,000.00 from Grantor to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is 10.000%.

Property. The word "Property" means the real property, and all improvements thereon, described above in the "Assignment" section.

Real Property. The words "Real Property" mean the property, interests and rights described above in the "Property Definition" section.

Related Documents. The words "Related Documents" mean and include without limitation all promissory notes, credit agreements, loan agreements, guarantes, security agreements, mortgages, deeds of trust, and all other instruments, agreements and documents, whether now or hereafter existing, executed in connection with the indabledness.

Rents. The word "Rents" means all rents, revenues, income, issues, and profits from the Property, whether due now or later, including without limitation all Rents from all leases described on any exhibit attached to this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE (1) PAYMENT OF THE INDESTEDNESS AND (2) PERFORMANCE OF ANY AND ALL OSLIGATIONS OF GRANTOR UNDER THE NOTE, THIS ASSIGNMENT, AND THE RELATED DOCUMENTS. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this assignment, Grantor shall pay to Lender ell amounts secured by this Assignment as they become due, and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender entercises its right to collect the Rents as provided below and so long as there is no default under this Assignment, Grantor may remain in possession and control of and operate and manage the Property and collect the Rents, provided that the granting of the right to collect the Rents shall not constitute Lender's consent to the use of cash collected in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Granky represents and werrants to Lender that:

Ownership. Grantor is entitled to receive the Plants free and clear of all rights, loans, liens, enoumbrances, and claims except as disclosed to and accepted by Lender in writing.

Right to Assign. Grantor has the full right, power, and suthority to enter into this Assignment and to easign and convey the Rents to Lender.

No Prior Assignment. Granter has not previously assigned or conveyed the Rents to any other person by any instrument now in force.

No Ferther Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights in the Flents except as provided in this Agreement.

LIBIDER'S RIGHT TO COLLECT RESTS. Lander shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Lender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the lenants or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.

Meintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of all confinuing costs and expenses of maintaining the Property in proper repair and condition, and also it may all toxes, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the Property.

Compliance with Laure. Light may do any and all things to execute and comply with the laws of the State of Blinds and also all other laws, rules, orders, orders, orders, and execute ments of all other governmental agencies effecting the Property.

Lease the Property. Lender may that or lease the whole or any part of the Property for such form or terms and on such conditions as Lender may deem appropriate.

APPLICATION OF RENTS. All costs and expenses incurred by Lenc et in connection with the Property shall be for Granton's account and Lender may pay such costs and expenses from the Rents. Lender, in its sole contains, shall determine the application of any and all Rents received by it, however, any such Rents received by Lender which are not applied to such costs and expenses shall be applied to the Indebtedness. All expenditures made by Lender under this Assignment and not reimbursed from the Rents shall be payable on demand, with interest at the Note rate from date of expenditure and paid.

FULL PERFORMANCE. It Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment, the Note, and the Related Documents, Lender shall execute and deliver to Grantor a suitable satisfaction of this Assignment and suitable statements of termination of any financing statement on the evidencing Lander's security I iteract in the Rents and the Property. Any termination fee required by the shall be paid by Grantor, If permitted by applicable law.

EXPENDITURES BY LENDER. If Grantor fells to comply with any provision of this Assignment, of hum, action or proceeding is commenced that would malerially affect Lender's interests in the Property, Lender on Grantor's behalf may, but shall not be mounted to, take any action that Lender deems appropriate. Any amount that Lender expends in so doing will beer interest at the rate charged unid in the Note from the date incurred or paid by Lender to the date of repayment by Grantor. All such expenses, at Lender's option, will (a) be payable on pointed, (b) be added to the halance of the Note and be apportioned among and be payable with any installment payments to become due during elbur. (b) the term of any applicable insurance policy or. (ii) the remaining term of the Note, or. (c) be treated as a balloon payment which will be due and pay ble at the Note's maturity. This Assignment also will secure payment of these amounts. The rights provided for in this paragraph shall be included as one of the default so as to be Lender from any remedy that it otherwise would have had.

DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default ("Event of Default") under this Ar s'in iment:

Detailt on Indebtedness. Fallure of Granfor to make any payment when due on the Indebtedness.

Compliance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Assignment, the Note or in any of the Related Documents. It such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) months, it may be cured (and no Event of Default will have occurred) if Grantor, after Lander sends written notice demanding cure of such failure: (a) cures the failure within fifteen (15) days; or (h) if the cure requires more than fifteen (15) days, immediately initiales steps sufficient to cure the failure and thernafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Assignment, the Note or the Related Documents is, or at the time made or furnished was, falso in any material respect.

Other Defaults. Failure of Grantor to comply with any term, obligation, covenant, or condition contained in any other agreement between Grantor and Lender.

Insolvency. The insolvency of Grantor, appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency taws by or equinst Grantor, or the dissolution or termination of Grantor's existence as a going business (if Grantor is a business). Except to the extent prohibited by tederal law or filtrois law, the death of Grantor is an inclvidual) also shall constitute an Event of Default under this Assignment.

Foreclosure, Fortetture, etc. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or Any other method, by any creditor of Grantor or by any governmental agency against any of the Property. However, this subsection shall not apply in the event of a good telth dispute by Grantor as to the velicity or reasonableness of the claim which is the basis of the foreclosure or forelature proceeding, provided that Grantor gives Lender written notice of such claim and furnishes reserves or a surely bond for the claim satisfactory is Lender.

Events Affecting Guarantor. Any of the praceding events occurs with respect to any Guarantor of any of the indebtedness or such Guarantor dies or becomes incompetent. Lender, at its option, may, but shall not be required to, permit the Guarantor's estate to assume unconditionally the obligations arising under the guaranty in a manner satisfactory to Lender, and, in doing so, cure the Event of Detault.

insecurity. Lendar reasonably deems itself insecure.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Delault and at any time thereafter, Londor may exarcise any one or more of the lollowing rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantor to deciare the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.

Collect Flents. Lender shall have the right, without notice to Grantor, to take possession of the Property and collect the Flents, including amounts past due and unpaid, and apply the net proceads, over and above Lender's costs, egainst the Indebtedraes. In furtherance of this right, Lender may require any tenant or other user of the Property to make payments of rent or use less directly to Lander. If the Rents are collected by Lender, then Grantor irrevocably designates Lender as Grantor's attorney-in-fact to endorse instruments received in payment thereof in the name of Grantor and to negoliste the same and collect the proceeds. Payments by tenants or other users to Lendar in response to Lendar's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this wor pregraph either in person, by agent, or through a receiver.

Mortgages in Possition. Lander shall have the right to be pisced as mortgages in possession or to have a receiver appointed to take ion of all or any plut of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or ale, and to collect the revite from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebledness. The mortgages in possibility or receiver may serve without bond if permitted by law. Lander's right to the appointment of a receiver shall exist whether or not the apparent was of the Property exceeds the Indebtedness by a substantial amount. Employment by Lander shall not disquality a person from serving as a receiver.

Other Remedies. Lender shall have to other rights and remedies provided in this Assignment or the Note or by law.

Walver; Election of Remedies. A waive to any party of a breach of a provision of this Assignment shall not constitute a waiver of or prejudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lander to pursue any remedy shall not exclude pursuit of any other remedy, and a reaction to make expenditures or take action to perform an obligation of Granics under this Assignment after failure of Granfor to perform shift not affect Lender's right to declare a default and oxercise its remedies under this Assignment.

Attorneys' Fees; Expenses. If Lender institutes ally suit or action to enforce any of the terms of this Assignment, Lender shall be entitled to recover altorneys' tees at trial and on any appeal. What fer or not any court action is involved, all reasonable expenses incurred by Lander that in Lander's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shell become a part of the Indebtedness payable on demand and shall bear interest from the date of exponditure until repeid at the Note rate. Expenses covered by this paragraph include, without Emilation, however subject to any limits under ap licat le law, Lender's attorneys' lees and Lender's legal expenses whether or not there is a lawsuit, including attorneys' fees for bankruptcy proceedings (including attorts to modify or vacate any automatic stay or injunction), appeals and any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including foreclosure reports), surveyors' reports, and appraisal fees, and the insurance, to the extent permitted by applicable law. Grantor also will pay any court costs, in addition to all other sums provided by law.

MISCELLAMEOUS PROVISIONS. The following miscellameous provisions are a part of his Assignment:

Amendments. This Assignment, together with any Related Documents, constitues the order understanding and agreement of the paties as to the matters set forth in this Assignment. No alteration of or amendment to this Assignment shell be effective unless given in writing and signed by the party or parties sought to be charged or bound by the alteration or amendment.

Applicable Law, This Assignment has been delivered to Lander and accepted by Lander & the State of Illinois. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois.

Multiple Parties. All obligations of Grantor under this Assignment shall be joint and several, and all informaces to Grantor shall mean each and every Grantor. This means that each of the persons signing below is responsible for all obligations in the Assignment.

No Modification. Grantor shall not enter into any agreement with the holder of any mortgage, deed of trust, oi other security agreement which has priority over this Assignment by which that agreement is modified, amended, adended, or renewed with the prior written consent of Lander. Grantor shall neither request nor accept any future advances under any such security agreement withhul the prior written consent of

Severability. If a court of competent jurisdiction finds any provision of this Assignment to be invalid or unenforced as to any person or circumstance, such anding shall not render that provision invalid or unenforceable as to any other persons or circumstance. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be ed, it shall be chicken and all other provisions of this Assignment in all other respects shall remain valid and enforceable.

Successors and Assigns. Subject to the limitations stated in this Assignment on transfer of Grantor's interest, this Assignment shall be binding upon and inure to the benefit of the parties, their successors and assigns. If ownership of the Property becomes vested in a person other than Grantor, Lander, without notice to Grantor, may deal with Grantor's successors with reference to this Assignment and the Indebtedness by way of forbegrance or extension without releasing Grantor from the obligations of this Assignment or flability under the indebledness.

Time is of the Essence. Time is of the essence in the performance of this Assignment.

Waiver of Homestead Examption. Granfor heraby releases and waives all rights and benefits of the homestead examption laws of the State of Minots as to all indebtedness secured by this Assignment.

Walvers and Consents. Lender shall not be deemed to have waived any rights under this Assignment (or under the Related Documents) unless such waiver is in writing and signed by Lender. No delay or omission on the part of Lander in exercising any right shall operate as a waiver of such right or any other right. A waiver by any party of a provision of this Assignment shall not constitute a waiver of or prejudice the party's right otherwise to demand strict compliance with that provision or any other provision. No prior waiver by Lender, nor any course of dealing between Lender and Grantor, shall constitute a waiver of any of Lender's rights or any of Grantor's obligations as to any future transactions. Whenever consent by Lender is required in this Assignment, the granting of such consent by Lender in any instance shall not constitute continuing consent to subsecuent instances where such consent is recuired.
