MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on NOVEMBER 30, 1987. The mortgagor is JOHN L. HAYKORSON AND JORDIE D. HAYKORSON HIS WIFE ("Borrower"). This Security Instrument is given to GOLDMEL BANKER RESIDENTIAL MORTGAGE SERVICES, INC. ("Lender"). Borrower owes Lender the principal sum of NINETY THOUSAND AND NO/100TH Dollars (U.S. \$90,000.00).
