MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on DECEMBER 14, 1987. The mortgagor is RICHARD SKIBICKI AND ALICJA SKIBICKI, HIS WIFE ("Borrower"). This Security Instrument is given to GOLDWELL BANKER, RESIDENTIAL MORTGAGE SERVICES, INC., which is organized and existing under the laws of THE STATE OF CALIFORNIA, and whose address is 28 EXECUTIVE PARK, SUITE 200, IRVINE, CALIFORNIA 92714 ("Lender"). Borrower owes Lender the principal sum of FORTY-FIVE THOUSAND AND NO/100ths Dollars (U.S. \$45,000.00).
