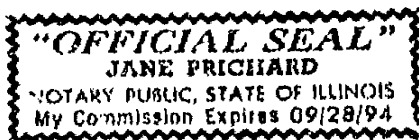

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on DECEMBER 10, 1987. The mortgagor is MARK A. TURZA AND ALINA TURZA, HIS WIFE ("Borrower"). This Security Instrument is given to GOLDWELL BANKER RESIDENTIAL MORTGAGE SERVICES, INC. which is organized and existing under the laws of THE STATE OF CALIFORNIA and whose address is 28 EXECUTIVE PARK, SUITE 200, IRVINE, CALIFORNIA 92714 ("Lender").
