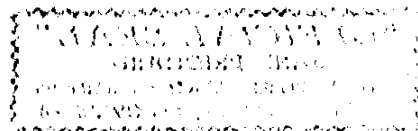

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on JULY 22 1987. The mortgagor is DALE L. SUSTEK AND BARBARA A. SUSTEK, HIS WIFE ("Borrower").
