This matter coming before the Court for hearing on plaintiff Signal Capital Corporation's motion for default judgment against defendant Harry Barileau, such hearing having been continued from an initial hearing on September 29, 1992, at which time Harry Barileau appeared before the Court, the Court having reviewed Signal Capital Corporation's motion for default judgment and the affidavit of Cathleen E. Ash filed in support thereof, the Court finds:

1. Signal Capital Corporation filed this lawsuit on June 18, 1992.
2. Service of process was obtained on the defendant Harry Barileau on June 27, 1992.
3. Defendant filed his appearance on July 20, 1992.
4. On September 24, 1992, Signal Capital Corporation filed its notice and motion for default judgment and served a copy of such notice and motion on defendant.

5. On September 29, 1992, Signal Capital Corporation presented its motion for default judgment to the Court. Defendant appeared for such hearing. The Court continued said motion for further hearing to October 8, 1992, to allow defendant an opportunity to obtain counsel and to respond to said motion.

6. On October 8, 1992, Signal Capital Corporation again presented its motion to the Court. Defendant did not appear at this hearing.

7. Defendant Harry Barileau is hereby found to be in default in this action for his failure to answer or otherwise plead to the complaint.

8. The affidavit of Cathleen E. Ash filed in support of Signal Capital Corporation's motion establishes defendant's liability to be \$338,862.81.

IT IS HEREBY ORDERED:

Judgment is hereby entered against defendant Harry Barileau and in favor of Signal Capital Corporation in the amount of \$338,862.81.
