STATE OF ILLINOIS  
COUNTY OF COOK  
IN SENATE  
JANUARY 11, 1900

RESOLVED, That the following be the law to be observed in the election of members of the Board of Supervisors of the County of Cook, to-wit:

SECTION 1. That the Board of Supervisors of the County of Cook shall be composed of nine members, to-wit: three from each of the three wards into which the County of Cook is divided, to be elected by the qualified electors of each ward at the general election to be held on the first Tuesday of the month of November in each year.

SECTION 2. That the Board of Supervisors shall hold office for a term of one year, and shall be eligible for re-election.

SECTION 3. That the Board of Supervisors shall meet on the first day of January in each year, and shall continue to meet until the first day of January in the next year.

SECTION 4. That the Board of Supervisors shall have the honor and privilege of sitting in the Senate Chamber of the State of Illinois, and shall be entitled to the same honors and privileges as are accorded to the members of the Senate of the State of Illinois.

SECTION 5. That the Board of Supervisors shall have the right to call and receive the attendance of any person who may be summoned by them, and to punish any person who may be found guilty of contempt of their authority.

SECTION 6. That the Board of Supervisors shall have the right to make and alter the rules and regulations of their own body, and to enforce the same.

SECTION 7. That the Board of Supervisors shall have the right to make and alter the rules and regulations of the Board of Election Commissioners of the County of Cook, and to enforce the same.

SECTION 8. That the Board of Supervisors shall have the right to make and alter the rules and regulations of the Board of Assessors of the County of Cook, and to enforce the same.

SECTION 9. That the Board of Supervisors shall have the right to make and alter the rules and regulations of the Board of Commissioners of the County of Cook, and to enforce the same.

SECTION 10. That the Board of Supervisors shall have the right to make and alter the rules and regulations of the Board of Commissioners of the County of Cook, and to enforce the same.
