1. ASSIGNMENT. No rents or security deposits under any of the Leases have previously been assigned by Grantor to any party other than Lender.

Grantor has not accepted, and will not accept, rent in excess of one month in advance under any of the Leases. Grantor has the power and authority to execute this Assignment.

Grantor has not performed any act or executed any instrument which might prevent Lorier from collecting rents and taking any other action under this Assignment.

5. GRANTOR MAY RECEIVE RENTS. As long as there is no default under the Note described above, this Mortgage securing the Note, this Agreement or any other present or future obligation of Borrower or Grantor to Lender ("Obligations"), Grantor may collect all rents and profits from the Leases when due and may use such proceeds in Grantor's business operations. However, Lender may at any time require Grantor to deposit all rents and profits into an account maintained by Grantor or Lender at Lender's Institution.

6. DEFAULT AND REMEDIES. Upon default in the payment of, or in the performance of, any of the Obligation. Lender may at its option take possession of the real property and the improvements and have, hold, manage, lease and operate the Premises on thin 3 and for a period of time that Lender deems proper. Lender may proceed to collect and receive all rents, income and profits from the Premises, and I under shall have full power to periodically make alterations, renovations, repairs or replacements to the Premises as Lender may deem proper. 7. POWER OF ATTORNEY. Grantor irrevocably authorizes Lender as Grantor's attorney-in-fact coupled with an interest, at Lender's option, upon taking possession of the real property and improvements under this Assignment, to lease or re-lease the Premises or any part thereof, to cancel and modify Leases, evict tenants, bring or defend any suits in connection with the possession of the Premises in the name of either party, make repairs as Lender deems appropriate and perform such other acts in connection with the management and operation of the real property and improvements as Lender may deem proper. The receipt by Lender of any rents, income or profits under this Assignment after institution of foreclosure proceedings under the Mortgage shall not cure any default or affect such proceedings or sale which may be held as a result of such proceedings.

8. BENEFICIAL INTEREST. Lender shall not be obligated to perform or discharge any obligation, duty or liability under the Leases by reason of this Assignment. Granter hereby agrees to indemnify Lander and to hold Lender harmless from any and all liability, loss or damage which Lender may incur under the Leases by reason of this Assignment and from any and all claims and demands whatsoever which may be asserted against Lender by reason of any alleged obligations or undertakings on Lender's part to perform or discharge any of the terms or agreements contained in the Leases.
