5TH NOTE AND MORTGAGE MODIFICATION AGREEMENT

THIS AGREEMENT is made this 30th day of January, 1993 by and between LOIS A. HOPKINS, an unmarried person. (herein "Debtor") and WESTBANK, an Illinois banking corporation (herein "Lender")

WHEREAS, Debtor has executed and delivered to Lender, (i) that certain Note dated July 28, 1988 in the original face amount of SIXTY THOUSAND AND NO/100 DOLLARS (\$60,000.00) (the "Note"), which was due, if not sooner paid on January 24, 1989 and extended to July 24, 1989 by Note dated January 24, 1989 and extended to November 15, 1989 by Note dated July 24, 1989 and extended to February 13, 1990 by Note dated November 16, 1989 in the amount of FIFTY-FOUR THOUSAND ONE HUNDRED EIGHTY-SEVEN AND 49/100 DOLLARS (\$54,187.49) and extended to May 14, 1990 by Note dated February 13, 1990 in the amount of FORTY-EIGHT THOUSAND THREE HUNDRED SEVENTY-TWO AND 64/100 (\$48,372.64) and extended to August 14, 1990 by Note dated May 14, 1990 in the amount of FORTY-EIGHT THOUSAND EIGHT HUNDRED SEVENTY-TWO AND 64/100 (\$48,872.64) and extended to November 14, 1990 by 1st Note and Mortgage Modification Agreement recorded in the Office of the Recorder of Deeds of Cook County, Illinois on August 23, 1990 as Document No. 3906442 and extended to January 15, 1991 by a 2nd Note and Mortgage Modification Agreement in the amount of THIRTY-THREE THOUSAND TWO HUNDRED EIGHTY-THREE AND 34/100 DOLLARS (\$33,283.34) recorded in the Office of the Recorder of Deeds of Cook County, Illinois on December 26, 1990 as Document No. 3974636 and further extended to July 15, 1991 by a 3rd Note and Mortgage Modification Agreement recorded in the Office of the Recorder of Deeds of Cook County, Illinois on March 7, 1991 as Document No. 3947980 and further extended to January 30, 1993 by a 4th Note and Modification Agreement in the amount of TWENTY NINE THOUSAND EIGHT HUNDRED THIRTY TWO AND 55/100 DOLLARS (\$29,832.55) recorded in the Office of the Recorder of Deeds of Cook County, Illinois on October 30, 1991 as Document No. 4006841.

WHEREAS, the Note is secured by a Mortgage (the "Mortgage") dated July 28, 1988 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on August 26, 1988 as Document No. 3734746 affecting real property described on Exhibit "A", which is attached hereto and made a part of hereof; and

2. Except as specifically modified by the terms hereof, the Note and the Mortgage shall be and remain in full force and effect and shall continue to govern the rights and obligations of the parties with respect to the loan evidenced and secured thereby.

- 1. The Note is hereby amended as follows:
 - A. The maturity date thereof is hereby extended to February 1, 1999.
 - B. The payment thereof is changed from interest at maturity to monthly payments of principal and interest of \$44.72 beginning March 1, 1993 to maturity.

NOW THEREFORE, for and in consideration of the foregoing, for the mutual covenants herein contained, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

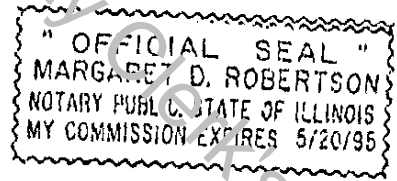

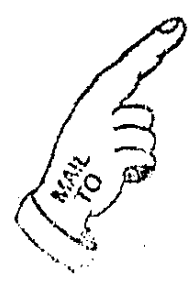
