LOAN MODIFICATION AGREEMENT

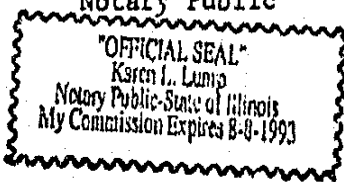
