### DECREE OF FORFEITURE

This matter coming to be heard on the motion of the United States of America to strike claimants' answer and for entry of a default decree of forfeiture, a verified

complaint having been filed in the above-entitled cause on July 16, 1987, monition having been served by the United States Marshal, and publication having been duly made according to law, and it appearing to the Court that it has jurisdiction and the Court being fully advised in the premises, it it hereby,

ORDERED that, with the exclusive exception of claimant Midwest Real Estate Investment Company, all persons and/or entities concerned be and hereby are held in default; it is further;

ORDERED that, in accordance with the claim of Midwest Real Estate Investment Company, the owner and holder of certificates of purchases for general taxes, all of which more fully appears from its claim duly filed with the Clerk of this District Court, forfeiture is subject to the liens in interest of Midwest Real Estate Investment Company in the real estate specifically designated in its claim; it is further;

ORDERED that the following defendant businesses and real properties, be and same hereby are condemned and forfeited to the United States in accordance with the provisions of 21 U.S.C. \$881(a)(6) and (a)(7):
