THE FOLLOWING ARE THE COVERNATE CONDITIONS AND PROVISIONS REPRESED TO DISPAGE 1 (THE REVERSE SIDE OF THIS FRUST DEED, WHICH THERE MEGISSION

- 1. Mortgagots shall (1) keep said premises in good condition and typast, without waste; (2) promptly repair, testore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) asep said premises free from mechanic's liers or liens in fovor of the United States or other liens or claims for her not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises amperior to the lien hereof, and upon request on this saisfactory evidence of the discharge of such prior her to Trinstee or to holders of the note; (5) complete within a reasonable time any buildings or buildings now or at any time in privates of election upon said premises, (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.

Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mongagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest or prior encurableaces, if, any, and purchase, discharge, compromise or settle any tax litin or other prior lien or title or claim thereof, or redeem from any let sale or forfellure affecting said premises or contest any tax or assessment. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trust e be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable to each or omissions hereinoder, except in case-of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he mit require indemnities satisfactory to him before exercising any power herein given:

Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has been fully paid, and Trustee may execute and deliver a release hereof to and at the request-of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor frustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be executed by a prior trustee hereindeer or which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and he has never executed a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine principal note and which purports to be executed by the persons herein designated as makers thereof.
 - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be accord. Successor in Trust, Any Successor in Trust hereunder shall have the identical title, powers and authority as are iterein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed licrounder.
