Mortgagee shall have the right to forcelose the lien hereof, in any out to forcelose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenougaphers' charges, probe atom costs and costs (which may be estimated as for items to be expended after entry of the device) of procuring all such abstract of title, title searches, and examinations, title maximize policies. Turrens certificates, and similar data and assurances with respect to title is a corresponding to the reasonably necessary either to prosecute such soil or to evidence to bidders at any sale which may be be I procurent to such decree the true condition of the title or the value of the premises. All expenditures and expense and expense thereon at or including herein to be common additional indebtedness secured hereby and immediately due and payable, with interest thereon at or including proceedings, to which the Mortgagee shall be a party, either as plaintiff, claimant or defendant, by reason of this mortgage of any indebtedness hereby secured; or (b) preparations for the commencement of any sunt for the forceionure hereof after accrual of such eight to toreclose whether or not actually security hereof.

11. The proceeds of any foreclosure sale of the premiser shall be distributed and applied in the following order of priority: First, on account of all costs and expenses rocident to the foreclosure proceedings, including all such items as an inentimed in the preceding paragraph hereof; second, all other items which under the terms betterf constitute secured indebtedness a ditional to that evidenced by the note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the real pointh, any overplus to Mottgagors, their heirs, legal representatives or usigns, as their rights may appear.

12. Upon or at any time after the filing of a complaint to fore lose this mortgage the court in which s.c., complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or involvency of Mortgagors at the time of application for such receiver and without regard to the then value or 1.2 premises or whether the same shall be then occupied as a homestead or not, and the Mortgagor may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full standary period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the projection, possession, control, management and operation of the premises during the such period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.

13. No action for the enforcement of the lien or of any provision bereof shall be subject to any defense which would not be good available to the party interposing same in an action at law upon the note hereby secured.

14. The Mortgagee shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

15. The Mortgagors shall periodically deposit with the Mortgagee such sums as the Mortgagee may reasonably require for paylient of taxes and assessments on the premises. No such deposit shall bear any interest.

The all the nayment of said indebtedness or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or precase, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation or release.

 $\gamma (\ell - 17)$. Mortgagee shall release this mortgage and lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a readprable fee to Mortgagee for the execution of such release.

"18. The mortgage and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein and the holder or holders, from time to time, of the note secured hereby.
