

(b) Also the Notes and indebtedness described in, and now secured by the instrument aforesaid.



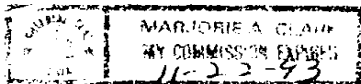


