- 3. Prior Mortgages and Beeds of Trust: Charges; Lieus. Borrower shall perform all of Borrower's obligations, under any morigage, deed of trust or other security agreement with a flen which has priority over this Mortgage, including Borrower's convenants to make payments when due. - 4. Hazard Insurance. - 11. Notice. - 12. Governing Law; Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. The foregoing sentence shall not limit the applicability of Federal law to this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflicts shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used herein "costs", "expenses" and "attorneys' fees" include all sums to the extent not prohibited by applicable law or limited herein.

- 14. Rehabilitation Loan Agreement. Porrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair or other loan agreement which Borrower enters into with Lender. NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follow:

- 16. Acceleration; Remedies. Upon Borrower's breach of any covenant or agreement of Porrower in this Mortgage, including the covenants to pay when due any sums under the Note secured by this Mort, age, Lender, at Lender's option may declare all sums secured by this Mortgage, to be immediately due and parable without demand or notice and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorneys' fees at a costs of documentary evidence, abstracts and title reports.
- 17. Assignment of Rents; Appointment of Receiver, Lender in Possession. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 16 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.
