AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF POSEN, COOK COUNTY, ILLINOIS

WHEREAS, Chapter 24, Section 7-1-13, Illinois Revised Statutes allows for annexation of surrounded or nearly surrounded territory under 60 acres by the passage of an ordinance, after proper notice is given, by any municipality which bounds such territory in whole or in part; and,

WHEREAS, the territory hereinafter described is 60 acres or less; and,

WHEREAS, said territory is wholly bounded by one or more municipalities; and,

WHEREAS, said territory is not within the corporate limits of any municipality but is contiguous to the Village of Posen; and,

WHEREAS, legal notice regarding the intention of the Village of Posen to annex said territory pursuant to Chapter 24, Section 7-1-13, Illinois Revised Statutes has been published in a newspaper of general circulation within said territory not less than 10 days before the passage of this annexation ordinance; and,

WHEREAS, all notices, documents and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically Chapter 24, Section 7-1-13, Illinois Revised Statutes; and,

WHEREAS, it is in the best interests of the Village of Posen that said territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF POSEN, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That the following described territory:

That part of the East 1/2 of the Southwest 1/4 and the Southeast 1/4 of Section 12, Township 36 North, Range 13 East of the Third Principal Meridian, North of the Indian Boundary Line, Cook County, Illinois, being described as follows:

Parcel "A": BEGIN at the centerline of 147th Street with the Westerly line of Vacated Francisco Avenue; thence West along said centerline of 147th Street to the Southwesterly line of the Tri-State Toll Road; thence Southeasterly along said Southwesterly line to the intersection of said Westerly line of the Vacated Francisco Avenue; thence North along said Westerly line to the POINT OF BEGINNING.

Parcel "B": BEGIN at the centerline of 147th Street with the centerline of California Avenue; thence East along said centerline of 147th Street to the Easterly line of Lot 1 of Duskin's First Subdivision extended North; thence South along said extended line to the South line of said 147th Street; thence West along said South line to the Westerly line of said Lot 1; thence South along said Westerly line of Lot 1 and Lots 2 and 3 of said Duskin's First Subdivision to the North line of Lot 4; thence East along said Lot 4 of said Duskin's First Subdivision to the East line of said Lot 4; thence South along said East line of Lot 4 and along the East line of Lot 5 of said Duskin's First Subdivision to the South line of said Lot 5; thence West along said South line to the Easterly line of said California Avenue; thence South along said Easterly line to the South line of Lot 6 of said Duskin's First Subdivision; thence East along said South line to the Westerly line of Harrison Avenue Gardens Subdivision; thence South along said Westerly line to the centerline of 149th Street; thence East along said centerline to the centerline of Harrison Avenue; thence South along said centerline to the centerline of 150th Street; thence West along said centerline to the said centerline of California Avenue; thence South along said centerline to the Southerly line of said 150th Street; thence West along said Southerly line to the Easterly line of Francisco Avenue extended South; thence North along said extended line and the said Easterly line of Francisco Avenue to the North line of said 149th Street; thence East along said North line to the Southwesterly line of the Tri-State Toll Road; thence Northwesterly along said Southwesterly line to the centerline of Vacated 148th Street; thence East along said centerline to the said centerline of California Avenue; thence North along said centerline to the POINT OF BEGINNING.

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
