Assignment of Mortgages

This Assignment is made by the RESOLUTION TRUST CORPORATION ("RTC"), a corporation existing under the laws of the United States of America, as Receiver for Duval Federal Savings Association, Jacksonville, Florida ("New Duval") (ASSIGNOR), 100 Colony Square, Suite 2300, Atlanta, Georgia 30361, to MIDLAND MORTGAGE CO. ("MIDLAND") (ASSIGNEE), an Oklahoma corporation, 3232 West Reno, Oklahoma City, Oklahoma 73107.

Whereas, the RTC was appointed as Receiver for Duval Federal Savings and Loan Association ("Old Duval") on January 17, 1990, by the Office of Thrift Supervision ("OTS") Order No. 90-130 pursuant to Section (d)(2)(H)(ii) of the Home Owners' Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"), and recorded in OR Book 7183, Page 617, of the current public records of Duval County, Florida; and

Whereas, Old Duval is the record holder of that certain mortgages more fully described herein ("Security Instrument"), and

Whereas, on January 17, 1990, the OTS by OTS Order No. 90-131, recorded in OR Book 7183, Page 614, of the current public records of Duval County, Florida, chartered a new federal savings association by the name of Duval Federal Savings Association ("New Duval"); and

Whereas, on January 13, 1990, Old Duval entered into a Purchase and Assumption Agreement with New Duval, recorded in OR Book 6827, Page 278, which agreement transferred certain of the assets, including the Security Instrument, to New Duval; and

Whereas, on January 17, 1990, the OTS by OTS Order No. 90-132, recorded in OR Book 7183, Page 611, of the current public records of Duval County, Florida, appointed the RTC as Conservator for New Duval; and

Whereas, on August 16, 1991, the OTS by OTS Order No. ATL-91-42 recorded in OR Book 7183, Page 608, of the current public records of Duval County, Florida, replaced the RTC as Conservator for New Duval with the RTC as Receiver for New Duval.

Now, Therefore, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the RTC as Receiver for New Duval does hereby convey, grant, bargain, sell, assign, transfer, and deliver to Midland the Security Instrument described in Schedule "A", attached hereto and made a part hereof, together with the certain Note(s) described therein, with all interest, all liens, and any rights due or to become due hereon. To have and to hold the same unto Midland, its successors and assigns forever.



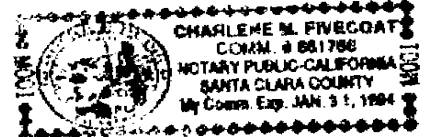
