SUBORDINATION OF MORTGAGE

Record, jointly and severally, do hereby covenant and agree with the said Bancplus Mortgage Corporation, that the lien of the note owned by River Forest State Bank and Trust Company and the mortgage securing the same shall be and remain at all times a second lien upon the premises thereby released except to the mortgage to Bancplus Mortgage Corporation, as aforesaid and for all advances made or to be made on the notes secured by the mortgage to Bancplus Mortgage Corporation, and for all other purposes specified herein.
