and in connection therewith and as part thereof, states as follows: That on and prior to 10/01/92 WAUCONDA NATIONAL BANK as TRUSTEE, U/T/A DATED 6/7/77, TRUST#77-137 was/were the owner(s) of the legally described property which is also commonly known as Arlington Heights, Illinois, and received and benefitted from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 11/01/92 and incurred a total charge of \$ 226.95 from the Village of Arlington Heights, which became due and owing on 11/21/92 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$ 249.65 and twenty-one (21) days thereafter, to wit on 12/10/92 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.
