WHEREAS, the Borrower has requested certain modifications of the said Note and Mortgage; THEREFORE, for good and valuable consideration, the parties do mutually agree that the Note and Mortgage are modified as follows:

Interest Rate: Effective on the date this egreement is executed, the interest rate of the Note is changed to 6.50% per annum. This rate shall remain fixed throughout the remaining term of the loan.

Principal Balance: The unpaid balance of the nate including any financed points is Seventy nine thousand eight hundred forty nine and 28/100 Collers (\$79,849.28). In consideration of this loan modification agreement, discount points in the amount of \$2,137.09 were paid.

Maturity Date: The maturity date of the note is not modified by this agreement. The maturity date is May 1, 2007.

Principal & Interest Payment: Borrower agrees to pay principal burness with interest at the above stated rate in monthly payments of Seven hundred twenty five and 11/100 Dollars (\$725.11).

Payment Due Date: The above payment amount shall be due monthly beginning on the 1st day of June 1993 and on the 1st of each month thereafter until above Note is fully paid, but no later than May 1, 2007.

Borrower covenants and agrees to pay the balance of the indebtedness evidenced of the Note and secured by the Mortgage as modified, and to perform the covenants contained in any Mortgage. Borrower further agrees that the prepayment privilege now in effect shall remain in rull force and effect. Borrower represents to Lender that there is no second mortgage or other subsequent the now outstanding against the Mortgaged Premises held by the Lender, except as otherwise disclosed in this Agreement, and that the lien of the Mortgage is a valid, first and subsisting lien on the Mortgaged Premises.

The parties acknowledge and agree that no liability whatsoever is admitted on the part of any party, except Borrower's indebtedness to Lender under the Note and Mortgage, and that all agreements and understandings between Borrower and Lender are expressed and embodied in the Note and Mortgage, as modified by this Agreement.
