WHEREAS, on July 10, 1992, Transohio Savings Bank was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5(d) (2) (A) of the Home Owners Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"). OTS pursuant to order number 92-307 appointed the Resolution Trust Corporation ("RTC") as Conservator of Transohio Savings Bank.

WHEREAS, on July 10, 1992, the OTS by order number 92-307 chartered Transohio Federal Savings Bank, as a federal mutual savings bank, and pursuant to Section 5 (d) (2) (B) (i) of HOLA, appointed the RTC as Conservator for Transohio Federal Savings Bank.

WHEREAS, on July 10, 1992, the RTC as Receiver of Transohio Savings Bank and the RTC as conservator of Transohio Federal Savings Bank purchased substantially all the assets, deposits and secured liabilities of the RTC as Receiver of Transohio Savings Bank.

WHEREAS, as a result of the transfer from the RTC as Receiver of Transohio Savings Bank, have a mailing address of 1250 Superior Avenue, Cleveland, Ohio 44114 is the owner and holder of the below mentioned Note and Mortgage.

NOW THEREFORE, the RESOLUTION TRUST CORPORATION as Conservator of Transohio Federal Savings Bank, as successor in interest to Transohio Savings Bank, owner and holder of the note evidencing the debt secured by the mortgage dated December 15th, 1986, in Book _____ of Page _____ as Document No. 86602084 covering the following described property in Cook County, Illinois:

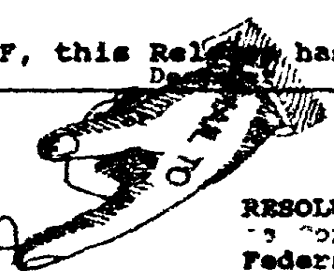
