That said contractor is entitled to credits on account thereof as follows: No/100 Dollars

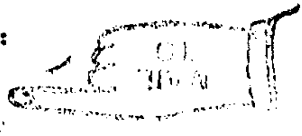

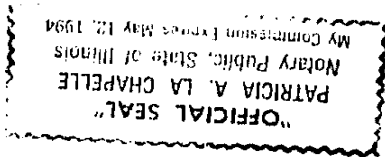
