## INSTRUCTIONS (Rev. 1/90)

1. PLEASE TYPE THIS FORM USING BLACK TYPEWRITER RIBBON.

2. If the space provided for any item is inadequate:

- a. Note "Cont'd." in the appropriate space(s).
- b. Continue the item(s) preceded by the Item No. on an additional 8 1/2"x11" sheet.
- c. Head each additional sheet with the Debtor's name (last name first for individuals) appearing in Item No. 1 of this form. Be sure to attach a copy of the additional sheet to each copy of the form.

3. NUMERICAL IDENTIFICATION:

- a. If the Debtor, Secured Party or Assignee is an individual, include Social Security number in the appropriate space. Disclosure of Social Security number is optional for the filing of this statement. It will be used to assist in correctly identifying individuals with similar names. (UCC § 9403(5))

5. SIGNATURES:

  - (2) proceeds under UCC § 9306, if the security interest in the original collateral was perfected. Such a financing statement must describe the original collateral and give the date of filing and the file number of the prior financing statement.
  - (3) collateral as to which the filing has lapsed. Such a financing statement must include a statement to the effect that the prior financing statement has lapsed and give the date of filing and the file number of the prior financing statement.
  - (4) collateral acquired after a change of name, identity or corporate structure of the debtor. Such a financing statement must include a statement that the name, identity or corporate structure of the debtor has been changed and give the date of filing and the file number of the prior financing statement and the name of the debtor as shown in the prior financing statement.

6. FILING FEE - PROPER PLACE TO FILE:

Enclose filing fee payable to the appropriate Filing Officer. Financing statements and related papers pertaining to consumer goods should be filed with the County Recorder in the county of the debtor's residence, or if the debtor is not a resident of this State, then in the office of the County Recorder of the county in which the goods are kept. In all other cases, filing is with the Secretary of State.
