SUBORDINATION OF LIEN

WHEREAS, DANIEL J. LAMORE AND ELIZABETH A. LAMORE, HIS WIFE by Mortgage dated SEPTEMBER 23, 1990 and recorded in the Recorder's office of COOK County, Illinois on OCTOBER 4, 1990 as Document Number 90K486483 did convey unto First Chicago Bank of St. Charles, National Association certain premises in COOK County, Illinois, described as follows:

NOW THEREFORE, in consideration of the premises and of the sum of ONE DOLLAR (\$1.00) to the undersigned in hand paid, First Chicago Bank of St. Charles, National Association does hereby covenant and agree with the said MANTENO BANK for the use and benefit of the legal holder of the notes secured by said Mortgage secondly herein described that the lien of the note owned by First Chicago Bank of St. Charles, National Association and of the Mortgage securing the same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the Mortgage to said MANTENO BANK as aforesaid for all advances made or to be made on the note secured by said last named Mortgage and for all other purposes specified therein.

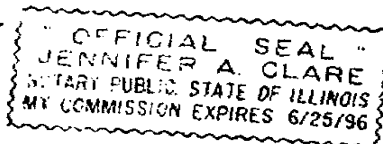
