#### ATTACHMENT RE: KOINONIA, INC.

ARTICLE 4: The purpose for which the corporation is organized are:

- A. To provide a more detailed and clearly defined corporate structure and procedure for the election of the trustees and officers of the New Faith Baptist Church, an Illinois religious corporation, and for the governance of such religious corporation, provided that the formation of this corporation and any action taken pursuant thereto shall be deemed not to constitute a waiver of any rights or privileges to which such religious corporation, its trustees, officers and members would otherwise be entitled, or to waive end immunity or exemption which they or any of them may have from any tax, law or regulation, whether now in effect or which hereinafter may be enacted, of the United States of America, the State of Illinois and its sub-divisions or any other governmental body having jurisdiction.
- B. Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions based upon an amount agreed upon by the board of directors No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements and political campaign on behalf of any candidate for public office.
- D. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not a lowed (a) by a corporation exempt form Federal income tax under Section 501(c)(3) of the Internal Revenue Code.
- E. Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the

Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Circuit Court shall determine, which are organized and operated exclusively for such purposes.
