- The Exclusive Parking Use to Parking Space 4 is hereby transferred from Declarant to Diftier and Parking Space 4 shall be a Limited Common Blemont appurtenant, and is hereby assigned, to Unit 2B.
- The Declarant and Diftler hereby state that no changes in the undividend whership in the Common Blements of any Unit are made by the transfer effected by this Pirst Amendment, and that no other Unit Owners have any right to use the Limited Common Blements affected by this First Amendment.

Except as herein specifically amended, the Declaration is ratified and confirmed in its entirety.
