This cause coming on to be heard upon the complaint of the plaintiff, BERNARD A. HEEREY

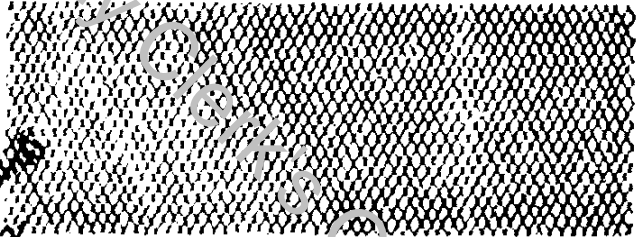
and the issues thereof having been heard and determined by the Court and said Court having found that the
