THIS MORTCAGE, SECURITY AGREEMENT AND FINANCING STATEMENT (the "Mortgage") is made as of the 270 day of 1993, by and between American National Bank and Trust Company of Chicago, not personally, but as Trustee under Trust Agreement dated July 5, 1991 and known as Trust Number 114190-09 (the "Mortgagor"), with offices at 33 North LaSalle Street, Chicago, Illinois 60690, and LaSalle Bank Like View (the "Mortgagee"), with offices at 3201 North Ashland Avenue, Chicago, Illinois 60657-2107.

WITNESSETH:

WHEREAS the sole beneficiary of the Mortgagor is Tinley Park Center Partnership, an Illinois general partnership (the "Beneficiary") and the Beneficiary and the Mortgagor are justly indebted to the Mortgagee in the principal sum of \$3,600,000 evidenced by that certain Promissory Note of Beneficiary and Mortgagor of even date herewith (the "Note"), made payable to the order of and delivered to the Mortgagee, whereove the Beneficiary and Mortgagor promised to pay the said principal sum, late charges, and interest at the rate and in installments, all as provided in the Note. The final payment of principal and interest, if not sooner paid, shall be due on May 15, 1908. All such payments on account of the Indebtedness (as that term is hereinafter defined) secured hereby shall be applied first to interest on the unpaid principal balance, secondly to any other sums due thereunder, thirdly to all other advances and sums secured hereby, and the remainder to principal, all of said principal and interest being made payable at such place as the holder of the Note may from time to time in writing appoint, and in the absence of such appointment, then at the office of the Mortgagee; and

WHEREAS, to secure the Note, the Mortgagee has required that the Beneficiary direct the Trustee to cause this Mortgage to be duly executed in favor of Mortgagee.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. Maintenance, Repair and Restoration of Improvements, Payment of Prior Liens, etc.

1.a. Right to Contest

Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any Lien not expressly subordinated to the lien hereof, and defer payment and discharge thereof during the pending of such contest, provided: (i) that such contest shall have the effect of preventing the sale or forfeiture of the Premises or any part thereof, or any interest therein, to satisfy such Lien; (ii) that, within ten (10) days after Mortgagor has been notified of the assertion of such Lien, Mortgagor shall have notified Mortgagee in writing of Mortgagon's intention to contest such Lien, and (iii) that Mortgagor shall have deposited with Mortgagee at such place as Mortgagee, may from time to time in writing appoint, a sum of which shall be sufficient, in the judgment of the Mortgagee, to pay in full such Lien and all interest which might become due thereon, and shall keep on deposit an amount so sufficient at all times, increasing such amount to cover additional interest whenever, in the judgment of the Mortgagee, such increase is advisable. Such deposits, if held by Mortgagee, are to be held without any interest accruing to the benefit of the Mortgagor or Beneficiary, If Mortgagor shall fail to prosecute such contest with reasonable diligence or shall fail to pay the amount of the Lien plus any incerest finally determined to be due upon the conclusion of such contest, to the extent such amount exceeds the amount which Mortgages will pay as provided below, or shall fail to maintain sufficient rinds on deposit as hereinabove provided, Mortgagee may, at its option, apply the money so deposited with Mortgagee in payment of or on account of such Lien, or that part thereof then unpaid, together with all interest thereon, if any. If the amount of money so deposited with Mortgagee shall be insufficient for the payment in full of such Lien, together with all interest thereon Mortgagor shall forthwith, upon demand, deposit with Mortgagee a sum which, when added to the funds then on deposit, shall be sufficient to make such payment in full. Mortgagee shall, upon the Final disposition of such contest, apply the money so deposiced in full payment of such Lien or that part thereof then unpaid, together with all interest thereon, if any, (provided Mortgagor is not then in default hereunder) when so requested in writing by Mortgagor and when furnished by Mortgagor with sufficient funds to make such payment in full and with evidence satisfactory to Mortgagee of the amount of payment to be made. After such payments, any sums thereafter remaining shall be refunded to Mortgagor.

2. Payment of Taxes

Mortgagor shall pay all general taxes before any penalty or interest attaches, and shall pay all special taxes, special assessments, water charges, sewer service charges, and all other charges against the Premises of any nature whatsoever when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor within thirty (30) days following the date of payment. Mortgagor shall pay in full "under protest" any tax or assessment which Mortgagor may desire to contest, in the manner provided by law.

3. Tax Deposits

Mcrtgagor shall deposit with the Mortgagee or such depositary (the "Depositary") as the Mortgagee may from time to time in writing appoint, and in the absence of such appointment, then at the office of Mortgagee in Chicago, Illinois, commencing on the date of dispursement of any portion of the proceeds of the loan secured hereby and on the first day of each month following the month in which said disbursement occurs, a sum equal to 105% of the amount of all real estate taxes and assessments (general and special) next due upon or for the Premises (the amount of such taxes next due to be based upon the Mortgagee's reasonable estimate as to the amount of taxes and assessments to be levied and assessed) reduced by the amount, if any, then on deposit with the Mortgagee or the Depositary, divided by the number of months to elapse before one (1) month prior to the date when such taxes and assessments will become due and payable. Such deposits are to be held without any allowance for interest to Mortgagor and are to be used for the payment of taxes and assessments (general and special) on the Premises next due and payable when they become due. If the funds so deposited are insufficient to pay any such taxes or assessments (general or special) when the same become due and payable, the Mortgagor shall, within ten (10) days after demand therefor from the Mortgagee or Depositary, deposit such additional funds as may be necessary to pay such taxes and assessments (general and special) in full. If the funds so deposited exceed the amount required to pay such taxes and assessments (general and special) for any year the excers shall Said deposits be applied to a subsequent deposit or deposits. need not be kept separate and apart from any other funds of the Mortgagee or the Depositary.

If any such taxes or assessments (general or special) shall be levied, charged, assessed or imposed upon or for the Premises, or any portion thereof, and such taxes or assessments shall also be a levy, charge, assessment or imposition upon or for any other premises not encumbered by the lien of this Mortgage, then the computation of any amount to be deposited under this Paragraph 3

3.a. Insurance Deposits

For the purpose of providing funds with which to pay premiums when due on all policies of fire and other hazard insurance covering the Premises and the Collateral, as that term is defined in this Mortgage, after a default hereunder and if requested by Mortgagee, Mortgagor shall deposit with the Mortgages or the Depositary, commencing on the date of disbursement of any portion of the proceeds of the Note and on the first day of each month following the month in which said disbursement occurs, a sum equal to the Mortgagee's estimate of the premiums that will next become due and payable on such policies reduced by the amount, if any, then on deposit with the Mortgagee or the Depositary, divided by the number of months to elapse before one (2) month prior to the date when such premiums become due and payable. No interest shall be allowed to Mortgagor on account of any deposit made hereunder and said deposit need not be kept separate and apart from any other funds of the Mortgagee or the Depositary.

4. Mortgagee's Interest in and Use of Tax and Insurance Deposits; Security Interest

In the event of a default bereunder, the Mortgagee may, at its option but without being required so to do, apply any monies at the time on deposit pursuant to Paragraphs 3 and 3.a. hereof to any of Mortgagor's obligations contained herein or in the Note, in such order and manner as the Mortgagee may elect. When the Indebtedness has been fully paid, any remaining deposits shall be paid to Mortgagor or to the then owner or owners of the Premises as the same appear on the records of the Mortgagee. A security interest, within the meaning of the Uniform Commercial Code of the State of Illinois, is hereby granted to the Mortgagee in and to all monies at any time on deposit pursuant to Paragraphs 3 and 3.a. hereof and such monies and all of Morgagor's rights, title and interest therein are hereby assigned to Mortgagee, all as additional security for the Indebtedness hereunder and shall, in the absence of default hereunder, be applied by the Mortgagee or Depositary for such purposes as the Mortgagee shall direct and shall not be subject to the direction or control of the Mortgagor; provided, however, that neither the Mortgagee nor the Depositary shall be liable for any failure to apply to the payment of taxes or assessments or insurance premiums any amount so deposited unless Mortgagor, while not in default hereunder, shall have furnished Mortgagee with the original bills

Neither Mortgagee nor the Depositary shall be liable for any act or omission taken in good faith, but only for its negligence or willful misconduct.

5. Insurance

Mortgagor shall keep all improvements and the Collateral now or hereafter situated on, or used in connection with, said Premises insured against loss or damage by fire on a socalled "All Risks" basis and against such other hazards as may reasonably be required by Mortgagee, including without limitation of the generality of the foregoing: (a) rent loss or business interruption insurance whenever in the opinion of the Mortgagee such protection is necessary; and (b) flood insurance whenever same is available and, in the opinion of Mortgagee, such protection is necessary. Mortgagor shall also provide insurance coverages with such limits for personal injury and death and property damage as Mortgagee may from time-to-time require. Mortgagee shall have the right to direct that any or all of the limits of coverage of the insurance policies herein described be increased to such amounts as the Mortgagee shall, from time-to-time, in the exercise of its reasonable business judgment deem appropriate. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts satisfactory to Mortgagee, with waiver of subrogation and replacement cost endorsements and a stangard non-contributory Mortgagee clause attached to all policies, including a provision requiring that the coverages evidenced thereby shall not be terminated or materially modified without thirty (30) days' prior written notice to the Mortgagee. Mortgagor shall deliver all original policies, including additional and renewal policies, to Mortgagee and, in the case of insurance about to expire, shall deliver renewal policies not less than thirty (30) days prior to their respective dates of expiration.

Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained hereunder unless Mortgagee is included thereon under a standard non-contributory mortgagee clause acceptable to Mortgagee. Mortgagor shall immediately notify Mortgagee whenever any such separate insurates is taken out and shall promptly deliver to Mortgagee the original policy or policies of such insurance. In the event of a receclosure of the lien of this Mortgage, or of a transfer of title to the Premises either in lieu of foreclosure or by purchase at the foreclosure sale, all interest in all insurance policies in force shall pass to Mortgagee, transferee or purchaser, as the case may be.

Within ninety (90) days following the end of each fiscal year of Mortgagor, at the request of the Mortgagee, Mortgagor agrees to furnish evidence of replacement cost, without cost to the Mortgagee, such as are regularly and ordinarily made by insurance companies to determine the then replacement cost of the building(s) and other improvements on the Premises.

Adjustment of Losses with Insurer and Application of Proceeds of Insurance

In case of loss or damage by fire or other casualty, Mortgages is authorized: (a) to settle and adjust any claim under insurance policies which insure against such risks; or (b) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid in regard to such loss. In either case, Mortgagee is authorized to collect and receipt for any such insurance monies. Such insurance proceeds may, at the option of the Mortgagee be: (x) applied in reduction of the Indebtedness, whether due or not; or (y) held by the Mortgagee and applied to pay for the cost of repair, rebuilding or restoration of the buildings and other improvements on the Premises. If the Mortgagee shall allow the insurance proceeds to be used for repair, restoration or rebuilding, then the Mortgagee agrees to make said proceeds available to reimburse Mortgagor for the cost of repair, rebuilding or restoration of buildings or other improvements on the Premises, provided that such proceeds shall be made available in the manner and under the conditions that the Mortgagee may require; in such event, the buildings and other improvements shall be so repaired, restored or rebuilt so as to be of at least equal value and substantially the same character as prior to such damage or destruction. If the cost of rebuilding, repairing or restoring the buildings and other improvements may reasonably exceed ten percent (10%) of the unpaid principal balance as of the date of damege or destruction, then the Mortgagee must approve all plans and specifications of such work before such work shall be commenced. If the proceeds are made available by the Mortgagee to reimburse the mortgagor or any lessee for the cost of repair, rebuilding or restoration, any surplus, after payment of the cost of repair, repullding, restoration and the reasonable charges of the Disbursing Party, as that term is hereinafter defined, shall, at the option of the Mortgagee, be applied on account of the Indebtedness or paid to any party entitled thereto as the same appear on the records of the Mortgagee. Notwithstanding anything contained herein to the contrary, Mortgagee agrees that the insurance proceeds will be applied as provided in Section 6 (y) hereof if and so long as the following conditions are satisfied: (i) the Mortgagor is not then in default under this Mortgage, the Note or the other Loan Documents; (ii) no fact, circumstance, event or condition has occurred which might ripen into a default under this Mortgage,

the Note, or the other Loan Documents; (iii) the proceeds of insurance together with funds of Mortgagor on deposit with the Mortgagee are sufficient in Mortgagee's reasonable judgment to fully repair and restore the Premises so damaged to its condition immediately prior to the time of such casualty; and (iv) the Premises may legally be restored to the condition and use existing immediately prior to such casualty. In addition, if Mortgagor deposits additional funds with Mortgagee to repair or restore the Premises, Mortgagor shall be entitled to interest on such deposited funds.

As used in this Paragraph 6, the term "Disbursing Party" refers to the Mortgagee and to any responsible trust or title insurance company selected by the Mortgagee.

7. Scarp Tax; Effect of Changes in Laws Regarding Taxation

If, by the laws of the United States of America or of any state or subdivision thereof having jurisdiction over the Mortgagor, Mortgagee or the Premises, any tax is due or becomes due in respect of the issuance of the Note or any document securing same, the Mortgagor covenants and agrees to pay such tax in the manner required by any such law. The Mortgagor further covenants to reimburse the Mortgagee for any sums which Mortgagee may expend by reason of the imposition of any such tax.
