## MEMORANDUM OF JUDGMENT

On December 17, 1992, a Judgment for Dissolution of Marriage was entered in the above-captioned cause which provided, in part:

"K. As and for his contribution to the Petitioner's attorneys' fees and costs, the Respondent shall pay to GEOFFREY C. MILLER, the Petitioner's attorney, the sum of \$1,400.00, and a Judgment is hereby entered in favor of the said attorney and against the Respondent in the amount of \$1,400.00. Immediately upon the closing of the sale of the former marital residence of the parties, the Petitioner shall pay to her attorney the sum of \$1,750.00, as and for the balance of her attorneys' fees and costs. The obligations of the parties to the said GEOFFREY C. MILLER shall be a lien against the former marital residence and the said attorney shall be entitled to record a Memorandum of Judgment evidencing the said obligations. The Respondent shall be solely responsible for and shall pay his own attorneys' fees and costs, incurred in connection with this dissolution action."
