MEMORANDUM OF SUBLICENSE AGREEMENT

This Memorandum of Sublease Agreement is made and entered into effective as of the first day of March, 1993 by and between First Chicago Trust Company of Illinois, as successor trustee to First Chicago Bank of Ravenswood, as Trustee under Trust Agreement dated July 13, 1990 and known as Trust No. 25-10879 ("Trustee") and Metropolitan Nursing Center of Elmwood Park Limited Partnership, an Illinois limited partnership (the "Partnership"; the Partnership and Trustee are hereinafter referred to collectively as "Sublessor"), and Elmwood Care Building Corp., an Illinois corporation ("Sublessee").


