That part of Lot 5 in the Subdivision of Joseph A. Barnes' Farm in Section 9, 15 and 16, Township 41 North, Range 11 East of the Third Principal Meridian, described as follows:

Beginning at a point on the north line of Section 16 that is 190.00 feet west (as measured along said north line of Section 16) of the east line of Lot 5, said east line also being the centerline of Arlington Heights Road as shown on the Subdivision of Joseph A. Barnes' Farm per Document No. 2826756 recorded May 29, 1899; thence on an assumed bearing of North 89 degrees 44 minutes 21 seconds East along the north line of Section 16, 190.00 feet to the said centerline of Arlington Heights Road; thence South 3 degrees 25 minutes 59 seconds West along said centerline of Arlington Heights Road, 164.08 feet (164.00 feet, record); thence South 89 degrees 44 minutes 21 seconds West, 57.00 feet; thence North 4 degrees 23 minutes 57 seconds East, 51.07 feet; thence northwesterly along a tangential curve, concave to the southwest, radius 35.00 feet, central angle 34 degrees 39 minutes 36 seconds, 57.82 feet to a point of tangency; thence South 89 degrees 44 minutes 21 seconds West, 96.53 feet to a point on the east line of Lot 3 in Shiner's Subdivision as registered February 6, 1989 as Document No. 3774026; thence North 3 degrees 25 minutes 59 seconds East along said east line of Lot 3 for a distance of 75.16 feet to the point of beginning, in Cook County, Illinois.

Beginning at a point on the south line of grantor's property, said point being the northeastern corner of Lot 2 in Shiner's Subdivision as registered February 6, 1989 as Document No. 1774026; thence on an assumed bearing of South 89 degrees 44 minutes 21 seconds West along the north line of said Lot 2 for a distance of 6.92 feet; thence North 4 degrees 23 minutes 57 seconds East 30.82 feet; thence South 85 degrees 36 minutes 03 seconds East, 10.00 feet; thence South 4 degrees 23 minutes 57 seconds West, 30.00 feet; thence South 89 degrees 44 minutes 21 seconds West, 3.12 feet to the point of beginning, in Cook County, Illinois.
