The Director of the Office of Thrift Supervision issued Order number(s) 90-43 dated January 10, 1990, placing St. Charles Savings and Loan Association in receivership and appointing the Resolution Trust Corporation as Receiver of St. Charles Savings and Loan Association pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

The Director of the Office of Thrift Supervision, by Order number(s) 90-44 and 90-45 dated January 10, 1990, incorporated a new federal savings association, St. Charles Federal Savings Association, and issued its charter appointing the Resolution Trust Corporation as Conservator for St. Charles Federal Savings Association, to have "all the powers of a conservator or receiver, as appropriate, granted under the Federal Deposit Insurance Act."

Certain assets of St. Charles Savings and Loan Association, including the asset which is the subject of this document, have been transferred from St. Charles Savings and Loan Association to St. Charles Federal Savings Association; and, for the purposes of confirming said transfer, St. Charles Savings and Loan Association does hereby grant, sell, assign, transfer, set over and convey to St. Charles Federal Savings Association, its successors and assigns, without recourse or warranty, any interest St. Charles Savings and Loan Association may have in the security document which is the subject of this document, together with the note, debt and claim secured by such security document and the covenants contained in such security document.

The Director of the Office of Thrift Supervision issued Order number(s) 90-2066 dated November 29, 1990, placing St. Charles Federal Savings Association in receivership and replacing the Conservator of St. Charles Federal Savings Association with the Resolution Trust Corporation as Receiver of St. Charles Federal Savings Association pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.
