2. OBLIGATIONS DEFINED. The term "Obligations" is defined as and includes the following:

A promissory note, No. BANK OF COUNTRYSIDE, T/U/T DATED 4-28-92 A/K/A TRUST #92-1148 A ID N DT PERSONALLY, MICHAEL B WARD, and LINDA S WARD (Borrower) payable in monthly payments to the order of Bank, which cylingers a loan (Loan) to Borrower in the amount of \$16,500.00, plus interest, and all extensions, renowals, modifications or substitutions if 6.70 xl.

B. All future advances by Bank to Borrower, to Mortgagor, to any one of them or to any one of them and others (and all other obligations referred to in the subparagraph(s) below, whether or not this Montgage is specifically rained to in the evidence of indebtedness with

regard to such future and additional indebtedness).

C. All additional sums advanced, and expenses incurred, by Bank for the purpose of insuring, proserving or otherwise protecting the Property (as herein defined) and its value, and any other sums advanced, and expenses incurred by Bank rursuant to this Mortgage, plus interest at the same rate provided for in the Note computed on a simple interest method.

D. - CONVEYANCE. - LIENS AND ENCUMBRANCES. Mortgagor warrants and represents that the Property is free and clear of all liens and encumbrances whatscever. Mortgagor agrees to pay all claims when due that might result, if unpaid, in the foreclosure, execution or imposition of any lien, claim or encumbrance on or against the Property or any part thereof. Mortgagor may in good faith contest any such lien, claim or encumbrance by posting any bond in an amount necessary to prevent such claim from becoming a lion, claim or encumbrance or to provent its foreclosure or execution,
- 6. ASSIGNMENT OF LEASES AND RENTS. Mortgager hereby absolutely assigns as additional security all present and future leases and rents, issues and profits effective immediately upon the execution of this Mortgager also coverants and agrees to keep, observe and perform, and to require that the length keep, observe and perform, all of the covenants, agreements and provisions of any present or future leases of the Property. In case Mortgagor she's nuglect or roluse to do so, than Bank may, at Bank's option, perform and comply with, or require performance and compliance by the initials, with any such lease covenants, agreements and provisions. Any sums expended by Bank in performance or compliance therewith or in enforcing such performance or compliance by the tenants (including costs, expenses, attorneys' tees and parallegal tees) shall accrue interest from the date of such expenditures at the same rate as the Obligations and shall be paid by Mongagor to Bank upon demand and shall be deemed a part of the debt and Obligations and recoverable as such in all respects.

- 8. REMEDIES ON DEFAULT. At the option of Bank, all or any part of the principal of, and accrued interest on, the Obligations shall become immediately due and payable without notice or demand, upon the occurrence of an Event of Default or at any time thereafter. In addition, upon the occurrence of any Event of Default, Bank, at its option, may immediately commence foreclosure proceedings and may immediately invoke any or all other remedies provided in the Note, this Mortgage or related documents. All rights and remedies are distinct, cumulative and not exclusive, and Bank is entitled to all remedies provided by law or equity, whether or not expressly set forth.
- DUE ON SALE OR ENCUMBRANCE. Bank may, at Bank's option, declare the entire balance with all accrued interest on the Obligations to be immediately due and payable upon the contract for, or creation of, any flen, encumbrance, transfer or sale of the Property, or any portion thereof, by Mortgagor. Lapse of time or the acceptance of payments by Bank after such creation of any lien, encumbrance, transfer or calle, or contract for any of the foregoing, shall not be dearned a waiver or estoppel of Bank's right to accelerate the Obligations. If Bank exercises such option to accelerate. Bank shall mail, by certified mail or otherwise, Mortgagor notice of acceleration to the address of Mortgagor shown on Bank's records; the notice shall provide for a period of not less than 30 days from the date the notice is mailed within which Mortgagor shall pay the sums declared due. If Mortgagor fails to pay such sums prior to the expiration of such period, Bank may, without further notice or demand on Mortgagor, Invoke any remedies permitted on Default. This covenant shall run with the Property and shall remain in effect until the Obligations and this Morigage are fully

- 10. POSSESSION ON FORECLOSURE. If an action is brought to foreclose this Mortgage for all or any part of the Obligations, Mortgager agrees that the Bank shall be entitled to immediate possession as Mortgages in possession of the Property to the extent not profibbled by law, or the count may appoint, and Mortgager hereby consents to such appointment, a receiver to take possession of the Property and to collect and tectare rents and profits arising therefrom. Any amounts so collected shall be used to pay taxes on, provide insurance for, pay costs of needed repairs and for any other expenses relating to the Property or the foreclosure proceedings, sale expenses or as authorized by the court. Any sum remaining after such payments will be applied to the Obligations.
- 11. PROPERTY OBLIGATIONS. Morigagor shall promptly pay all taxes, assessments, levies, water rents, insurance promisms and all amounts due on any encumbrances, it any, as they become due. Morigagor shall provide written proof to Bank of such payment(s).
- 12. INSURANCE. Mortgagor shall insure and keep insured the Property against loss by fire, and other hazard, casualty and loss, with extended coverage including but not limited to the replacement value of all improvements, with an insurance company acceptable to Bank and in an amount acceptable to Bank. Such insurance shall contain the standard "Mortgagee Clausti" and where applicable, "Loss Payee Clause", which shall name and endorse Bank as mortgagee and loss payee. Such insurance shall also contain a provision under which the insurer shall give Bank at least 30 days notice before the cancellation, termination or material change in coverage.

If an insurer elects to pay a fire or other hazard loss or damage claim rather than to repair, rebuild or replace the Property lost or damaged, Bank shall have the option to apply such insurance proceeds upon the Obligations secured by this Mortgage or to have said Property repaired or rebuilt. Mortgager shall deliver or cause to deliver evidence of such coverage and copies of all notices and renewals relating thereto. Bank shall be entitled to pursue any claim under the insurance if Mortgager falls to promptly do so.

Mortgagor shall pay the trentums required to maintain such insurance in effect until such time as the requirement for such insurance terminates. In the event Mortgagor falls to pay such premiums, Bank may, at its option, pay such premiums. Any such payment by Bank shall be repayable upon demand of Bank or If no demand in accordance with the paragraph below titled "BANK MAY PAY".

- 13. WASTE. Mortgagor shall not allone's or encumber the Property to the projudice of Bank, or commit, permit or suffer any waste, impairment or deterioration of the Property, and regardless of natural depreciation, shell keep the Property and all its improvements at all times in good condition and repair. - 15. SPECIAL INDEMNIFICATION. Mortgagor agrees to protect, indemnity, defend and hole Pan', harmless to the fullest extent possible by law and not otherwise, from and against all claims, demands, causes of action, suits, losses, damages, (including, without limitation, punitive damages, if permitted by law), violations, environmental response and/or cleanup costs, fines, penalties and arranses, including, without limitation, reasonable attorneys' fees, costs and expenses lincurred in investigating and defending against the assertion of such liabilities, as such fees, costs and expenses are incurred, of any nature whatsoever, which may be sustained, suffered or incurred by Bank based upon, without limitation: the ownership and/or operation of the Property and all activities relating thereto; any knowing or material misrepresentation or material breach of warranty by Mortgagor; any violations of the Comprehensive Environmental Response, Compensation and Liability Act of 1980 and any other applicable federal, state or local rule, ordinance or statute; the cleanup or removal of hazardous waste or evaluation and investigation of the release or threat of release of hazardous waste; any loss of natural resources including damages to air, surface or ground water, soil and picture and any private suits or court injunctions.

- 17. PROTECTION OF BANK'S SECURITY. If Mortgagor fails to perform any covenant, obligation or agreement contained in the Note, this Mortgage or any loan documents or if any action or proceeding is commenced which materially affects Bank's interest in the Property, including, but not limited to, foreclosure, eminent domain, insolvency, housing or environmental code or law enforcement, or errangements or proceedings involving a bankrupt or decedent, then Bank, at Bank's sole option, may make such appearances, disburse such sums, and take such action as is necessary to protect Bank's interest. Mortgagor hereby assigns to Bank any right Mortgagor may have by reason of any prior encumbrance on the Property or by law or otherwise to cure any default under said prior encumbrance. Without Bank's prior written consent, Mortgagor will not partition or subdivide the Property.
- 18. COLLECTION EXPENSES. In the event of any default or action by Bank for collection of the Obligations, for protection of the Property or for foreclosure, Mortgagor agrees to pay all fees and expenses incurred by Bank. Such fees and expenses include but are not limited to filing fees, stenographer fees, witness fees, costs of publication, foreclosure minutes, and other expenses of collecting, enforcing and protecting the Property and Obligations. Any such collection expenses shall be added to the principal amount of the Obligations, shall accrue interest at the same rate as the Obligations and shall be secured by this Mortgage.
- 19. ATTORNEYS' FEES. In the event of any default or action by Bank for collection of the Obligations, for protection of the Property or for foreclosure. Mortgagor agrees to pay reasonable attorneys' fees and other legal expenses incurred by Bank. Any such reasonable attorneys' fees shall be added to the principal amount of the Obligations, shall accrue interest at the same rate as the Obligations and shall be secured by this Mortgago.

20. CONDEMNATION. In the event all or any part of the Property (including but not limited to any easement therein) is sought to be taken by private taking or by virtue of the law of eminent domain, Mortgagor will promptly give written notice to Bank of the institution of such proceedings. Mortgagor further agrees to notify Bank of any attempt to purchase or appropriate the Property or any easement therein, by any public authority or by any other person or corporation claiming or having the right of eminent domain or appropriation. Mortgagor further agrees and directs that all condemnation proceeds or purchase money which may be agreed upon or which may be found to be due shall be paid to Bank as a prepayment under the Note. Mortgagor also agrees to notify the Bank of any proceedings instituted for the establishment of any sewer, water, conservation, ditch, drainage, or other district relating to or binding upon the Property or any part thereof. All awards payable for the taking of title to, or possession of, or demage to all or any portion of the Property by reason of any private taking, condemnation, eminent domain, change of grade, or other proceeding shall, at the option of Bank, be paid to Bank. Such awards or compensation are hereby assigned to Bank, and judgment therefor shall be entered in favor of Bank.

When paid, such awards shall be used, at Bank's option, toward the payment of the Obligations or payment of taxes, assessments, repairs or other items provided for in this Mortgage, whether due or not, all in such order and manner as Bank may determine. Such application or release shall not cure or waive any default. In the event Bank deems it necessary to appear or answer in any condemnation action, hearing or proceeding, Mortgager shall hold Bank harmless from and pay all legal expenses, including but not limited to reasonable attorneys' fees and paralegal tees, court costs and other expenses.

- 21. OTHER PROCEEDINGS. If any action or proceeding is commenced to which Bank is made or chooses to become a party by reason of the execution of the Note, this Mortgage, any loan documents or the existence of any Obligations or in which Bank doesns it necessary to appear or answer in order to project its interests, Mortgager agrees to pay and to hold Bank harmless for all liabilities, costs and expenses paid or including but not limited to reasonable atternays' fees, paralogal fees, court costs and all other damages and expenses.
- 22. WAIVER BY MORTGAGOR. To he extent not specifically prohibited by law, Mortgagor hereby waives and releases any and all rights and remedies Mortgagor may now have or acquite in the future relating to:

A. homestead;

B. exemptions as to the Property:

C. redemption;

D. right of roinstatement;

E. appraisement;

F. marshalling of liens and assets; and

G. statutes of limitations.

In addition, redemption by Mortgagor after foreclosure nale is expressly waived to the extent not prohibited by law.

- 23. PARTIAL FORECLOSURE. In case of default in the payment of the Obligations or in case of payment by Bank of any tex, Insurance premium, cost or expense or the filling, imposition or ettachment of any ten judgment or encumbrance, Bank shall have the right, without declaring the whole indebtedness due and payable, to foreclose against the Property or any part thereof on account of such specific default. This Mongage shall continue as a lien on any of the property not sold on toreclosure for such impaid before of the Obligations.
- 24. BANK MAY PAY. If Mortgagor falls to pay when due any of the items it is unligated to pay or fails to perform when obligated to perform, Bank may, at its option:
 - A. pay, when due, installments of principal, interest or other obligations, in accordance with the terms of any mortgage or assignment of beneficial interest senior to that of Bank's lien interest;

B. pay, when due, installments of any real estate tax imposed on the Property; or

C. pay or perform any other obligation relating to the Property which affects, at Bank's sale discretion, the interest of Bank in the Property.

Mortgagor agrees to indemnify Bank and hold Bank harmless for all the amounts so paid and for Bank's costs and expenses, including reasonable attorneys' fees and paralegal fees.

Such payments when made by Bank shall be added to the principal balance of the Obligations and's rail oear interest at the rate provided for by the Note as of the date of such payment. Such payments shall be a part of this lien and shall be secured by this Mortgage, having the benefit of the lien and its priority. Mortgager agrees to pay and to reimburse Bank for all such payments.

25. GENERAL PROVISIONS.

- A. TIME IS OF THE ESSENCE. Time is of the essence in Morigagor's performance of all duties and obligations imposed by this Morigage.
- B. NO WAIVER BY BANK. Bank's course of dealing, or Bank's forbearance from, or delay in, the exercise of any of Bank's rights, remedies, privileges or right to insist upon Mortgagor's strict performance of any provisions contained in this Mortgago, or other toan documents, shall not be construed as a waiver by Bank, unless any such waiver is in writing and is signed by Bank. The acceptance by Bank of any sum in payment or partial payment on the Obligations after the balance is due or is accelerated or after toreclosure proceedings are filled shall not constitute a waiver of Bank's right to require full and complete cure of any existing default for which such actions by Bank were taken or its right to require prompt payment when due of all other remaining sums due under the Obligations, nor will it cure or waive any default not completely cured or any other defaults, or operate as a defense to any foreclosure proceedings or deprive Bank of any rights, remadles and privileges due Bank under the Note, this Mortgage, other loan documents, the law or equity.

C. AMENDMENT. The provisions contained in this Mortgage may not be amended, except through a written amendment which is signed by Mortgagor and Bank.

D. FURTHER ASSURANCES. Mongagor, upon request of Bank, agrees to execute, acknowledge, deliver and record or file such further instruments or documents as may be required by Bank to secure the Note or confirm any lien.

E. GOVERNING LAW. This Mortgage shall be governed by the laws of the State of ILLINOIS, provided that such laws are not otherwise preempted by federal laws and regulations.
