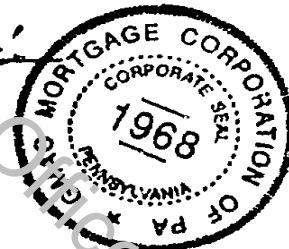

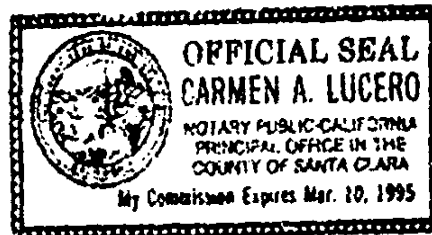
1. That notification was given to Melvin J. Gillespie at
