THE NOTE CONT. U'IS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY OFF TIME AND THE MAXIMUM RATE THE BORROWER MUST PAY.
